### IP Fellows to Host International Attorneys and Present Patent Law Survey at Symposium on Friday, April 11

Professor Randy Berholtz and a Research Team of IP Fellows will host a symposium for patent attorneys and students to hear from patent examiners in key jurisdictions, international attorneys and representatives from pharmaceutical and biotechnology companies.

"I would like to encourage you all to come to our Thomas Jefferson School of Law Conference on the Topic of *Where to File: A Framework for Biotechnology and Pharmaceutical*

*Companies to Develop an International Patent Filing Strategy* that will be held at the law school on Friday from 7:30 a.m. to 7:00 p.m.," said Professor Berholtz.

The goal of the symposium is to provide a learning opportunity and a venue for attorneys and students to network on a global scale. The all-day event will draw attorneys from all around the globe including India, South Africa, Europe, Brazil, Australia and China, as well as representatives from the European Patent Office and the State Intellectual Property Office (China).

The Team will be presenting the survey results, and hosting a series of panel discussions with international patent attorneys regarding the strategies currently used, the major international patent filing systems, and the concept of a World Patent. This event will be open to students, faculty, staff, alumni and community members interested in the topic. California attorneys in attendance can elect to receive up to 7.5 hours of CLE credit.

The event will be held in room 323 and is free for TJSJL faculty, staff, alumni, students and non-TJSJL students.

Guests are \$15, San Diego County Bar Association Members (seeking MCLE credit) are \$50 and non-TJSJL California attorneys (seeking MCLE credit) are \$75. Refreshments and beverages will be provided and there will also be a few door prizes.

Kimberly Roth, graduating Summa Cum Laude will be addressing the audience as Valedictorian. "I'm really excited to be Valedictorian of my graduating class," said Roth. "It means all of my hard work over the past three years paid off! These past three years have flown by, but I am eager to graduate, pass the bar, and enter the real world!"

In addition to tutoring and mentoring other law students, Roth currently interns at the Attorney General's Office. She has previously interned for Disability Rights California and for the San Diego County Office of the District Attorney.

During her time in law school, Roth served as Editor for Thomas Jefferson's Law Review and Vice Chair of TJSL's Moot Court Competition Team – which Roth describes as representing some of her most memorable experiences at TJSL. "Our team is like a family to me and I have thoroughly enjoyed working hard for competitions with my fellow teammates," she said.

"I was fortunate to take classes with some of the best professors around that were enthusiastic about the subjects they taught, happy to be teaching, and willing to go out of their way to see their students succeed," said Roth – who credits Professors Susan Bisom-Rapp, William Slomanson, Aaron Schwabach, Marybeth Herald, Julie Greenberg, Anders Kaye, K.J. Greene, Jane Seigel, Carmela Simoncini and Paul Spiegelman, for helping her develop her research, writing, and oral advocacy skills.

"I owe a huge *thank you* to everyone that helped me to be successful in law school. Most importantly, I would not be where I am today without the continuous love and support from my parents, sister, and friends. Their encouragement helped me work hard and push through the late study nights at the library and all-nighters at Lestat's Coffee House," added Roth.

The doors will open at 9 a.m. at [Copley Symphony Hall](#), 750 B Street, San Diego. The graduation ceremony starts promptly at 10 a.m.

The Spring 2014 commencement speaker is Board of Trustees member Judge Roger Benitez '78. The Honorable Roger T. Benitez was first appointed to the Superior Court of California in 1997, after previously working in general practice with a law firm. He served as Presiding Judge of the Appellate Division before being appointed as a United States Magistrate Judge for the Southern District in 2001. In 2004, he was appointed to the District Judge position he now holds. Judge Benitez has sat by designation numerous times with the Ninth Circuit Court of Appeals and also has sat on assignment in Arizona, Guam and Saipan. He is a charter member of the Wallace Inn of Court, currently chairs the Southern District's IT Committee and is a member of the U.S. Judicial Conference Committee on Financial Disclosure, having been appointed by Chief Justice John Roberts.



## Professor Dyson to Speak at 60th Anniversary of Brown v. Board of Education Decision on April 11

Professor Maurice Dyson will be speaking to a prestigious and historic gathering of national experts, policymakers, attorneys and scholars which include Jack Greenberg, Erwin Chemerinsky, The Hon. Nathaniel Jones, Charles Hamilton Houston, Jr., at a conference commemorating the 60th anniversary of the *Brown v. Board of Education* decision. Professor Dyson will speak on the Brown decision and offer a blueprint for the future of public education which is expected to draw large crowds and spark a conversation about the direction of education reform in the country.

"I am honored to be a part of this historic and pivotal dialogue that brings together some of the most committed and sharpest minds to consider how we can improve and implement effective educational models that deliver quality schooling, and equal opportunity which closes the national achievement gap."

According to the University of Missouri-Kansas City website "This historic gathering will take place at UMKC April 10 and 11. Co-sponsored by the UMKC School of Law and Michigan State School of Law, Pursuing the Dreams of Brown and the Civil Rights Act will bring together the litigants, attorneys, and others who were actually involved the Supreme Court's landmark 1954 decision in *Brown v. Board of Education*, the passage of the 1964 Civil Right Act, as well as the subsequent struggle for diversity and equality in education spanning the sixty years since the Brown decision.

Pursuing the Dreams will provide the audience an unparalleled interaction with those who have made history in the struggle for educational equality. Nationally known experts, as well as community leaders, will expand the perspective and add another dimension to those interactions. The symposium will also be an opportunity to look forward to the challenges that remain sixty years after Brown.

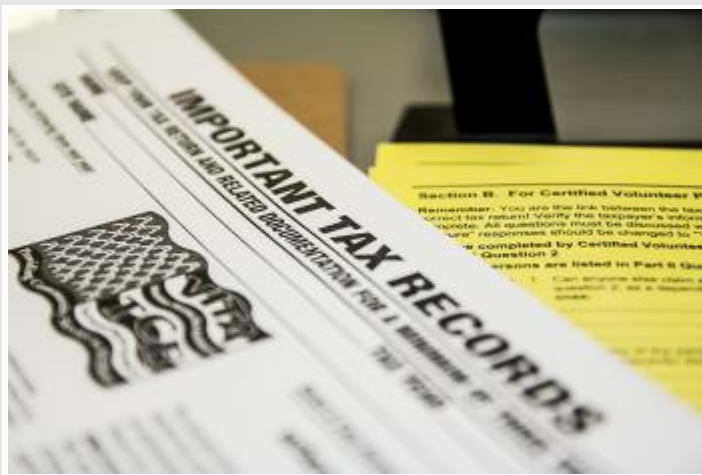
## Professor Bisom-Rapp to Speak at Emory Law School on April 26

Professor Susan Bisom-Rapp has been invited to speak at Emory Law School at *A Workshop on Labor and Employment Law*, which takes place April 25-26. The Workshop is part of a year-long celebration of the 30th anniversary of The Feminism and Legal Theory Project, which is directed by Emory Professor Martha Albertson Fineman. Professor Fineman began the project at Wisconsin Law School in 1984, then moved it to Columbia Law School when she joined that faculty, took it to Cornell Law School when she served on Cornell's faculty, and moved it finally to Emory Law School, where she is a Robert W. Woodruff Professor.

The April workshop will consider how issues affecting women should be analyzed and discussed at a time when laws against gender discrimination have been on the books for half a century, the problems of women workers are diverse, and the way people work has changed significantly. Professor Bisom-Rapp is presenting her paper *Navigating Gender Equality Deficits in a Post-Egalitarian, Intersectional World of Changing Work: The Case of Women's Poverty in Retirement*. The paper sets out a model, which was initially developed with her frequent co-author Malcolm Sargeant, for understanding why the poverty rate of women 65-years old and up is nearly double that of men of the same age. She argues that to understand the forces that produce this unbalanced result, policy makers must pay careful attention to the lives of girls and women both in terms of the decisions they make and the obstacles they confront. However, in solving the problem, Professor Bisom-Rapp recommends an approach that recognizes gender problems but moves beyond them to craft solutions that address the vulnerability of male and female workers, and improve the lives of retirees overall.

Professor Bisom-Rapp met Professor Fineman in 1993 when the former began her doctoral work at Columbia Law School. Professor Fineman was chair of Professor Bisom-Rapp's dissertation committee. While she was in residence at Columbia, Professor Bisom-Rapp worked for Professor Fineman as her assistant coordinator of the school's Women in the Legal Profession History Project. After defending her dissertation in 1996, Professor Bisom-Rapp joined the Thomas Jefferson School of Law faculty. In 2004, at Professor Bisom-Rapp's invitation, Professor Fineman, who had by that time joined the Emory faculty, agreed to travel to San Diego to give Thomas Jefferson's annual Ruth Bader Ginsburg Lecture. In 2005, Thomas Jefferson's Women and the Law Project joined with Emory's Feminism and Legal Theory Project to co-host a two day conference in San Diego, *The Global Impact of Feminist Legal Theory*. Joining with Professors Fineman and Bisom-Rapp in organizing that conference was Professor Linda Keller, who now is Associate Dean at Thomas Jefferson.

"I'm very much looking forward to celebrating the important work and the 30th anniversary of the Feminism and Legal Theory Project," said Professor Bisom-Rapp. "Reconnecting with my mentor and the many good friends who will participate in the workshop will be a career high point for me."



## VITA Tax Clinic is Open for 17th Season of Free Tax Return Services

From now until April 12, the Volunteer Income Tax Assistance (VITA) program operated by Thomas Jefferson School of Law's Tax Law Society, a student organization, will provide free income tax return preparation for students, low-income families, senior citizens and others who can't afford professional tax services or are unable to complete their own tax forms.

Since 1998, TJSL students have annually offered this service to the San Diego community. The clinic's student volunteers

receive training to become IRS-certified, operate the TaxWise software, interview clients effectively and assemble a proper tax return.

The TJSL tax clinic is open to walk-in clients on Tuesdays and Thursdays from 3-7 p.m.

The Tax Law Society is advised by TJSL Professor Richard Winchester, a former attorney in the national tax office of PricewaterhouseCoopers, who is a national authority on employment tax policy and the taxation of closely held businesses.

The tax clinic is located in the Law Clinic office at the Thomas Jefferson School of Law in the East Village area of downtown San Diego.

Items you need to bring to the TJSL Tax Clinic to have your tax returns prepared are:

- ◆ Proof of identification
- ◆ Social Security Cards for you, your spouse and dependents and/or a Social Security Number verification letter issued by the Social Security Administration
- ◆ Wage and earning statement(s) Form W-2, W-2G, 1099-R, from all employers
- ◆ Interest and dividend statements from banks (Forms 1099)
- ◆ A copy of last year's Federal and State returns if available
- ◆ Bank Routing Numbers and Account Numbers for Direct Deposit
- ◆ Total paid for day care provider and the day care provider's tax identifying number (the provider's Social Security Number or the provider's business Employer Identification Number)
- ◆ To file taxes electronically on a married filing joint tax return, both spouses must be present to sign the required forms.

## Business Law Society Hosts First Annual Drive: Pitch & Mix Event Featuring over 100 Local Business Owners and Entrepreneurs

On Friday, March 28<sup>th</sup>, the Business Law Society hosted DRIVE 2014, its first annual Pitch & Mix event. The combination Pitch-Night/Mixer saw student entrepreneurs pitch their business ideas to a panel of judges in a format akin to ABC's *SHARK TANK* before receiving feedback in the form of questions and dialogue about their businesses.

Business ideas ranged from health sciences—including intravenous vitamin therapy and a cure for cancer—to e-commerce and social networking portals aimed at taking a piece of the market away from companies like *eBay* and *MeetUp*. Moreover, a couple of the businesses even featured a legal bent: one a new tax software solution founded by a practicing tax attorney and the other a non-profit organization aimed at providing victim-support during the period following prosecution. David Duwe, a German student pursuing his MBA at San Diego State University, won the competition with his pitch for *Aspyrian Therapeutics*, a new start-up based in San Diego that focuses on developing novel, targeted therapies for cancer treatments.

Following the Pitch contest, guests were invited to the 3<sup>rd</sup> floor lobby for a Business Mixer wherein local entrepreneurs could connect with business-minded students from the San Diego legal community.

## Jakgeem Mays '10 Promoted to Legal Affairs Specialist at NBCUniversal

Hard work pays off, and no one knows that better than TJSU alum, Jakgeem Mays '10. After setting a goal to attend law school and transition into television, Jakgeem was recently promoted to the newly created Specialist, Legal Affairs role for NBCUniversal's Cable Entertainment Group. Jakgeem will draft and negotiate various agreements and handle other legal matters (e.g., rights, chain-of-title analysis) in connection with the development and production of scripted and unscripted programming at E!, Esquire Network, Wilshire Studios, Bravo, and Oxygen.

During his 1L year, Jakgeem learned about the T. Howard Foundation Internship Program through career services who encouraged him to apply. A non-profit organization, the T. Howard Foundation is committed to increasing ethnic diversity in the multimedia and entertainment industry. Jakgeem was selected after a competitive interview process and landed a paid internship at 20th Century Fox.

"Fox is known as a difficult studio to get into, so doors began to open for me after that – I clerked at a major immigration law firm and was hired for an internship at SAGAFTRA in the spring of my 2L year." Of career services Jakgeem says, "Whether providing a pep talk or useful information, Career Services helped me from day one. Assistant Dean for Career Services Beverly Bracker saw in me what some days I couldn't see in myself."

Halfway through law school, Jakgeem made the ultimate sacrifice and moved to Los Angeles after it was stressed to him the importance of taking advantage of networking opportunities in the industry. "While this created many challenges, at the end of the day I was positioned to take advantage of additional internships (Gospel Music Channel, NBCUniversal, etc.) and networking opportunities and eventually one day I got a call to come work in Business Affairs at NBC Entertainment / Universal Television."

Jakgeem is proud of the barriers he has broken to get where he is today. "As a practical matter, NBCUniversal typically hires lawyers from Top 20 law schools. When I first returned to NBCUniversal as a licensed attorney, I was told there was no opportunity for me here." However he continued to pursue his dream, stating that, "Tenacity and perseverance kept me going when I wanted to quit. It's really true what they say – winners do what losers are not willing to do." He is excited to bring his years of experience in entertainment and most important, passion for the industry to this new position.

The entertainment industry is fiercely competitive, but for those interested in pursuing this path Jakgeem advises, "It is imperative to take advantage of as many networking opportunities and internships as you can. Know your audience and be respectful of their time; more important, be professional. There are hundreds of people competing for one position. You will get a lot of no's but it only takes one yes to jump start your career."

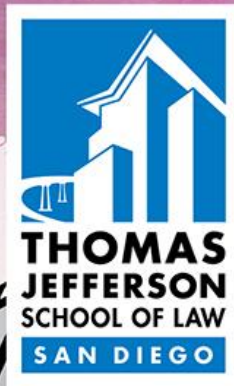

## Academic Success & the Writing Center Spring 2014 Workshops

### **Mixed Multiple Choice Madness** (Designed for Second Semester 1Ls)

**Friday, March 28, 11:30am – 12:45pm, room 227**

This workshop is designed with second-semester 1Ls participating in the bar-like final exam experience in mind. It will review some strategies and tactics for preparing for mixed-multiple choice exams, and provide some techniques for taking the mixed multiple choice exams. Participants will have an opportunity to practice some mixed-multiple choice questions.

### **Overcoming Analysis Paralysis**
