

TJSL Awarded LEED Gold Certification for its Green Building



TJSL Dean and President Rudy Hasl announced on Tuesday, January 22 that the law school's new downtown campus has achieved Gold Certification under the [U.S. Green Building Council's LEED \(Leadership in Energy and Environmental Design\) Program](#). "Going for the Gold" has been Dean Hasl's goal from the moment the new building was conceived.

"From the beginning of the construction process, the School sought to achieve LEED Gold status as a statement of its commitment to sustainability and environmental responsibility," said Dean Hasl. "Our achievement of this status stands as a symbol of our commitment to responsible energy management and our leadership within the legal education community. We have demonstrated with our investment in this project that we have backed up our rhetoric with tangible commitments." The new law school was designed and built to be as energy efficient as possible, to reduce the school's environmental footprint and to generate solar electricity for the San Diego Gas & Electric grid.

There is a 49 kilowatt photovoltaic energy system on the roof, owned and operated by SDG&E, that will generate clean electricity to be fed directly back into the grid – enough clean energy at peak production to power the law school and up to 32 homes. This renewable system was worth one point toward the 39 points needed to qualify for Gold Level LEED certification.

In recognition of these "green" efforts, SDG&E presented the law school with an incentive check for \$111,199 in March 2011 for its participation in the company's "Sustainable Communities Champions Award" and "Savings by Design" programs.

The building's mechanical equipment requires less energy to operate because of the building's lower heating and cooling demands. A "Cool Roof" membrane on the main roof reflects heat from the sun and reduces cooling loads on the building. The school's new server and network infrastructures also are saving on energy.

Another eco-friendly innovation is the use of Hycrete, a concrete admixture that turns regular concrete into a waterproof barrier. Hycrete was used for the foundation and flooring and the result is a highly desirable green environmental impact and great cost savings.

Other green features of the new campus include the availability of public transportation, with the trolley right on the school's doorstep and the use of low-emitting construction materials for the interior and innovation in the design process.

The landscaping is part of Dean Hasl's vision to create "an urban oasis" on the building's outdoor terraces with specially selected drought-resistant plants. The highlight of the oasis is the living wall on the fifth floor terrace – an 85 foot green wall of succulent plants that hides the view of the mechanical equipment on the roof of the building next door. The wall also creates a place of green solitude for students to study amid the concrete city surrounding the law school. The building design also conserves water – requiring an estimated 20 percent less water than average, while the water-efficient landscape design will require about 50 percent less water.

The new campus also include the availability of public transportation, with the trolley right on the school's doorstep; the use of low-emitting construction materials for the interior and innovation in the design process. The process of the final LEED Gold Certification shows that the TJSL campus is a sustainable and enduring environmentally-friendly landmark in San Diego's East Village – as well as a shining example of what a green law school can be. Rudy Hasl's reputation of being San Diego's "Green Dean" is well-deserved.

Tim Purpura '91: From Law School to Major League Baseball's Executive Suite

TJSL alumnus Tim Purpura '91 has had a lifelong love affair with baseball. It led him to his current position as the Senior Director of Player Development for the Texas Rangers, his former position as General Manager of the Houston Astros and many other positions in baseball as well.

His career story was an inspiration to those who heard him speak at TJSL on January 24, as he talked about his pathway from law school to baseball's executive suites, during a lunchtime event presented by the TJSL Alumni Association and the law school's Center for Sports Law and Policy.

Purpura says a bit of advice from his mentor, former Orioles and White Sox general manager Roland Hemond is what made

up his mind to go to law school. Hemond told him that "someday lawyers are going to run baseball."

Those were prophetic words, and today Purpura feels that not only are there a myriad of opportunities for lawyers in baseball, but in all professional and amateur sports. "Law school was my entrée into sports that I would not have had otherwise," he said.

In fact, Purpura was already interning with the then California Angels while he was at the law school when it was known as Western State University College of Law – flying back and forth between San Diego and the Angel's training facility in Arizona.

"They were exhausting times, but great times," Purpura said.

After law school, he followed former Angel's general manager Mike Port, who was founding the Arizona Fall League. "I used my law degree right off the bat to negotiate stadium leases around Phoenix," said Purpura. "But I also did everything from washing player's uniforms to raking the infield," adding that it was great experience for his later career as a baseball executive.

Being the GM of the Astros was "the epitome of what I aspired to in baseball," Purpura said. And so far, his greatest experience was the Astros playing in the World Series against his boyhood team, the Chicago White Sox, even though Chicago won the series. "The World Series was the highlight of my career, but losing in the World Series was the lowlight of my career," he said.

Purpura also told the audience some pretty colorful stories about his experiences in baseball, stories that included baseball greats like Albert Pujols, Craig Biggio and the late Ken Caminiti, among others.

As far as the climate in sports now, Purpura feels the two biggest issues are Performance Enhancing Drugs (PEDS) and inappropriate social media messages by players. "Every area of professional and amateur sports has lawyers involved with the PED problem," he said.

And he says there are so many opportunities in different areas of sports law, including licensing and workers compensation.

Event organizer Jeremy Evans '11 presented Purpura with a Distinguished Alumni Award and Purpura, in turn, said he is really impressed with the new TJSL campus. "It's amazing," Purpura commented. "I have to commend the law school for building a first-class facility with great amenities to help the students learn."

"We were delighted to have Tim Purpura join us and offer his words of wisdom," said Evans. "As I looked around the room during his speech, I could see eyes filled with wonder, dreams, and excitement, including my own, as Tim told his stories and experience working and living in America's Pastime. Very practical and honest advice of his path in sports and how we can get there too--hard work!"

It was a unique event for TJSL - Lawyers in Literature.

Professor Steve Semeraro read excerpts from his award-winning short story "The Birds They Sang at the Break of Dawn" at a special reception in the 8th floor conference room Wednesday evening, January 23.

The story, based loosely on the real-life career of TJSL alumnus and DUI attorney Eric Ganci '08, won the first ever Journal of Legal Education Fiction Contest in 2012, sponsored by Southwestern Law School in Los Angeles. The contest was judged by a panel of prominent writers and Professor Semeraro's story was selected as the best entry from among 129 from writers across the U.S. and several other countries.

An audience of fellow faculty members, alumni, students and staff came to the reading, as Professor Semeraro set the mood by positioning himself behind a music stand with an old-fashioned style microphone and a wine bottle atop an antique wooden stand next to him.

"Erica Lane's boyfriend called Gramchi first," said Professor Semeraro reading the opening lines of his story. "Around 10 the night before, Erica had flounced out the door with Sheila and some girls that Grail didn't know. She did this often; late nights were par for Erica's course. But when 2:30 came and went, Grail suspected that this wouldn't be a typical night. At 4:50, he heard the phone. He let it ring a little because he didn't want to rush into hearing what he knew would not be good. Erica had been arrested for DUI. Bad as it initially sounded, it only got worse."

As he read the story, Professor Semeraro interspersed background anecdotes on how he created the characters and his inspiration for the writing style he developed – from the works of Thomas Pynchon to a Rock and Roll Hall of Fame induction speech by Eric Clapton.

"Inspiration is likely to come from anywhere," said Professor Semeraro.

The story was also based on his own real-life experiences, according to Professor Semeraro, including a ride-along he did with the U.S. Park Police while he was working as an Assistant U.S. Attorney in Virginia.

That resulted in this colorful passage:

"Tom Foley, a young patrolman at the end of a long nightshift, pulled her over and saw an open bottle of Vodka on the front seat. He asked her to get out of the car, and after a short pause her mid-thigh-high boots reached tentatively for what she hoped was the ground. She couldn't walk a straight line. Hell, she couldn't walk a curved line. She could barely walk at all. Repeatedly, she screamed at Foley calling him a "Yogi-bear cop" whose ass her boyfriend would undoubtedly kick or something to that effect. Foley looked more like Booboo than Yogi, but you had to forgive her for the mistake. Most everyone made it."

In the audience was Eric Ganci, upon whom the character Gramchi is based. The story chronicles Ganci/Gramchi's decision to specialize in DUI cases – after a conversation with a homeless man who Ganci used to see regularly in the microfiche room at the old TJSL campus in Old Town. "Make yourself the very best at doing that one thing," said his gray and wizened street sage. And that's exactly what both Ganci... and Gramchi did.

"I am sooo beyond flattered," said Ganci of Professor Semeraro's fictional portrayal of him. "And it's also cool to see every level of TJSL here – from students to professors to alumni. This is a really nice event."

Ganci was also thankful for the special beer and wine-tasting created for the event by Associate Dean Eric Mitnick and Professor Semeraro, which was a hit with the literary crowd.

The evening was also a fund-raiser for the following three different and worthwhile projects. The first is an Alumni Association art gift, the second is a mural to grace the lobby of TJSL's law clinic offices, and the third is the sponsorship of clinical student.

"I enjoyed the opportunity to share the story behind *The Birds They Sand at the Break of Day* with my colleagues and alumni from throughout the school's history," said Professor Semeraro. "And as I said at the event, it gave me the chance to extend my 15 minutes of fame to ½ hour. The opportunity to raise money for TJSL's extensive clinical program was the icing on the cake for me. Even if you missed the event, please contribute to support the students in the various clinical programs."

"I really enjoyed the evening and especially Steve's presentation," said Dean Mitnick, one of the event's organizers. "There was a genuine warmth in the room among the faculty, staff, alumni, and students attending. Our hope is that it will be the first of many 'Evenings With' different faculty members."

TJSL Solo Practitioner Center has International Ties

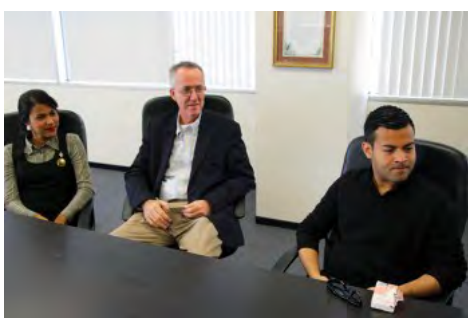


The Dominican Group had a Roundtable Meeting with TJSL's Solo Practitioners

“The incubator concept is spreading like wildfire,” said Fred Rooney, who developed the first incubator program at CUNY Law School in New York, and who helped start the incubator programs at both Thomas Jefferson and California Western schools of law.

The latest incubator program Rooney has established is in Santo Domingo, the Dominican Republic, where he is doing a Fulbright Scholarship this is the first incubator program in Latin America and the first outside the U.S.

On Monday, January 28, Rooney brought three Dominicans to San Diego to visit the Center for Solo Practitioners, TJSL's incubator program, which has been in operation since November 1. The visitors and the lawyers from the CSP met in a round table session to learn about each other's programs, with TJSL alumnus and solo practitioner Ben Aguilar '11 acting as the translator.

“San Diego is now an international hub for incubators, having two incubator programs,” said Rooney, whose program in Santo Domingo is being funded by the U.S. State Department.

The incubator in Santo Domingo is focusing on gender violence as well as serving the LGBT community there. Two Dominican law students, Emanuel Alcántara Alfonce and Luis Sosa Brea have been instrumental in setting up the program in Santo Domingo and Brigida Melo, a recent law school graduate will be directing the program.

“This is a great opportunity for people about to graduate,” said Sosa. “It is also giving back to the community,” he added, referring to the Santo Domingo center's mission of providing access to justice for people who can't afford lawyers.

That is the same mission as TJSL's incubator program, headed by Professor Lilys McCoy, who was pleased to host the Dominican delegation.

She is also responsible for the development of TJSL’s Center for Solo Practitioners, a lawyer incubator program.

Before arriving at TJSL, Professor Herrera had solo a practice in Compton, California and is also the co-founder and board president of Community Lawyers, Inc., a non-profit organization that provides low and moderate-income people access to affordable legal services and develops innovative opportunities for attorneys and law students in underserved communities.

Overall, I enjoyed being in the presence of such dynamic law students. We shared our interests and goals and made lasting contacts.

Roe v. Wade 40th Anniversary Dinner: TJSL is Well-Represented

The TJSL students who were present at the dinner are current members of Law Students for Reproductive Choice as well as past members who have graduated but are still active in reproductive justice because of their experiences at TJSL.

"The Roe v. Wade Dinner, with its theme of 'Reproductive Justice, Then and Now,' was empowering, because it showed how far the reproductive rights movement has come since the *Roe v. Wade* decision in 1973," said attendee Susy Prochazka 3L. "The event was also humbling, however, because it highlighted how much work still needs to be done to ensure that women have full access to these rights."



This year, San Diego attorney and reproductive rights champion Abby Silverman-Weiss was honored as the 2013 Defender of Choice.

"The 40th Anniversary *Roe v. Wade* Dinner program paid tribute to San Diego leaders who advocated for choice during an era when women had no access to legal abortions in the United States," said Professor Joy Delman, who attended the dinner and is faculty advisor to LSRJ. "California, and San Diego in particular, has always been at the forefront in protecting women's rights and choice in matters of reproduction. Ronald Reagan, as governor, legalized abortion in California in 1967, prior to the Supreme Court's decision in *Roe v. Wade*. Subsequent Supreme Court decisions concerning matters such as allowing women access to health clinics without having to endure direct confrontation by protestors, arose out of cases that were decided here or regulations first promulgated in California. The dinner paid tribute to those who played fundamental roles in securing those rights, and provided inspiration to those younger guests who are interested not only in preserving those rights, but in ensuring that all citizens have equal opportunity and access in order to exercise reproductive justice. "

The turnout reflected the strong and active chapter of Law Students for Reproductive Justice at TJSL – both past and present members.

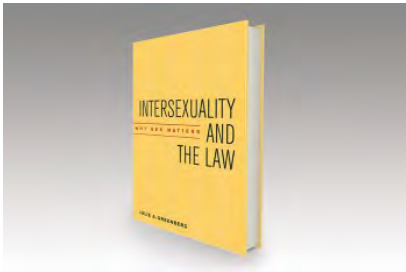

Few authors have illustrated such sustained commitment to understanding how intersexuality interacts with existing legal regimes, and Greenberg provides invaluable description, analysis, and critique."
