The venue is separate and distinct from the law school, specifically reserved as restaurant space. Bottega Americano will also be offering catering for all events taking place in the Thomas Jefferson Law School building's many venues and spaces and will be providing a meal plan to TJSL students as well.

Bottega Americano is the first concept created by four partners involved in San Diego's flourishing dining scene. Owners include Giuseppe Ciuffa, Founder and CEO of Giuseppe Fine Catering and Restaurants; practicing lawyer, investor and East Village resident Chad Ruyle; general manager Greg Van de Velde, who has consulted on several new restaurants and comes from the iconic Bertrand at Mister A's restaurant; and noted chef David Warner of San Diego's beachfront hotspot JRDN. Together, these four longtime San Diego residents will bring to life a new genre of dining inspired by European style.

The partners hired designer Thomas Schoos to help bring the vision of Bottega Americano to life. Recently, Schoos has garnered acclaim for his recent projects Searsucker, Herringbone and Puesto. The last few years have seen Schoos going more international, with projects in Beijing, Taipei and the south of France. Last May, Ellipsis opened in Mumbai, the first project Schoos has designed in India.

Every year, the program welcomes six to ten lawyers who have a desire to establish their own law practices.

Ben Aguilar '11 participated in the program last year. "This environment was a great support network," said Aguilar. "It was extremely helpful to come to work and have other attorneys to discuss cases with and get second opinions. As a result of joining the program, I have made some wonderful new friends and we have shared important milestones in our personal and professional lives. I am looking forward to continue working with this group of incredibly talented attorneys.

Because of the experience gained by his participation in the Incubator Program, Aguilar is expanding his business. "I just opened a second office location in Imperial County, so the plan is to continue growing my family law and immigration practice."

While building their practices, the lawyers are encouraged to provide pro-bono and low-bono services to increase the access to civil legal services for those in need. While providing those legal services, the incubator lawyers gain valuable legal experience.

"The center is devoted to two principles," said Director of the Center for Solo Practitioners and Solo Practice Concentration Professor Lilys McCoy. "The first is that everyone should have access to justice. People shouldn't be denied legal representation because they have too little, or for that matter, because you have too much. The second principle is that lawyers provide a tremendous service to society, but for lawyers to meet this noble obligation they themselves need support, mentoring, continuing education and they need each other."

"I would like to add a big thank you to Professor Lilys McCoy," said David Gibbs. "She has been a fantastic mentor and role model. I am incredibly grateful for all she has done for me and for Thomas Jefferson School of Law."

"My experience as a Solo Practitioner has been great," said David Meyer. "The Center has provided me with resources to get my practice going and keep it moving forward. I can't thank Professor McCoy enough."

50th Anniversary of Workplace Anti-Discrimination Law Forum

Equal employment opportunities for all—this is the message of Congress when it enacted Title VII of the Civil Rights Act of 1964. To commemorate fifty years of this historic legislation, the Labor and Employment Law Association (LELA) in cooperation with other student organizations held a forum on employment discrimination that tackled the lasting impact of the law that prohibited discrimination based on race, color, religion, sex, and national origin in the American workplace. The panel also discussed the challenges, the current and future prospects in this field of labor and employment law.

"Title VII is by far the most litigated area of the Civil Rights Act," started the event's keynote speaker, Mr. Bill Lann Lee of Lewis, Feinberg, Lee, Renaker & Jackson, as he shared insights about the history of the law and litigations on that field. He underscored the significance of the legislation in relation to Martin Luther King Jr.'s dream of reaching the "Promised Land."

Lee formerly served as Assistant Attorney General for the Civil Rights Division in the United States Department of Justice in the Clinton Administration. He also spent eighteen years as an attorney with the National Association for the Advancement of Colored People (NAACP) Legal Defense and Educational Fund in New York City and Los Angeles.

Lee contended that "the situation today is still the same as before" and is disheartened by issues in the effective implementation of the Civil Rights law and acknowledged the tension between the law's goals and courts' restrictive interpretation. Despite this however he asserted, "there is a way to successfully litigate under the Civil Rights Act" citing to the suits he successfully brought against big companies such as Wet Seal on discrimination of its African-American employees, and against Netflix on behalf of the National Association of the Deaf.

So "why should you be interested in employment discrimination?" asked Mr. Lee. He said that it is an opportunity to tackle unique challenges of the 21st century and help ensure equal opportunity for all.

Prof. Susan Bisom-Rapp, who was part of the panel, presented her recent scholarship on the problem of poverty for older women and highlighted that women suffer more in age discrimination. According to her, this, as well as other lingering discrimination in the workplace, can be attributed to the nation's scattershot approach. "There are many holes in the Civil Rights Act and the nation's labor and employment laws. Piecemeal solutions are not effectively addressing the problem. Our work isn't finished and the Civil Rights Act needs to adapt to the 21st century."

"We are still in the beginning stages of addressing employment discrimination in its various forms in society," said Professor Rebecca Lee, who presented another perspective from the academe. Prof. Lee shared her recent scholarship in the area of affirmative action and asserted, "there is compelling interest in workforce diversity." She highlighted that even Fortune 500 companies "recognized that the global economy required widely diverse people with different background in the workplace."


"The Civil Rights Act has made significant contribution in eradicating discrimination in the workplace, but I do agree much still need to be done," concluded TJSL's General Counsel Karin Sherr who moderated the forum. She echoed the panel's assertion that additional progress in this area of labor and employment law is needed to eliminate discrimination in the workplace.

In his welcome remarks, Dean Thomas Guernsey acknowledged the important role of student organizations in nurturing the intellectual traditions of TJSL. Aside from LELA, he thanked the other sponsors of the event: La Raza, Asian Pacific American Law Students Association (APALSA), National Lawyers Guild (NLG), Black Law Students Association (BLSA), Immigration Law Society (ILS), and Delta Theta Phi. Aside from the student organizations, LELA President Ian Seruelo also acknowledged the event's other sponsors: TJSL Center for Law and Social Justice, Kaplan Bar Review, and Champagne Bakery.

Talking the Talk for a Cause

On Saturday, April 19th, Phi Alpha Delta will present a production of the award-winning play The Vagina Monologues at hART Lounge. An all-female cast of TISL students will lend their acting talents to soliloquies that bring empowerment to women worldwide.

The performance is part of an international movement called V-DAY, founded by the play's author Eve Ensler, who wrote the play with the mission to "bring a deeper consciousness to the conversation around ending violence against women and girls."

Ensler wrote *The Vagina Monologues* as a collection of vignettes, based on interviews she conducted with more than 200 women. At times humorous, but always heartfelt, Ensler gracefully tells their stories, with each piece celebrating women's sexuality and strength by giving voice to experiences and feelings not previously exposed in public. Through the liberation of this one word from the taboo, Ensler has empowered countless women worldwide and started a grassroots campaign dedicated to generating awareness and funds to stop violence against women and girls in all its forms.

As an integral part of the V-Day campaign, each performance goes to benefit a program in the local community who shares the collective V-Day mission to end the cycle of violence against women. Phi Alpha Delta will donate a portion of the proceeds from this performance to Becky's House, a YWCA-affiliated domestic violence program located in downtown San Diego that provides a much-needed oasis of hope for women and children who may think they have no alternative than to remain in an abusive situation. Donations of women's products and non-perishables are also being collected on behalf of Becky's House, both at the door and in the PAD cube on the 5th floor.

Thomas Jefferson School of Law's Spring Commencement will be held on Saturday, May 17, 2014, 10 a.m., at Copley Symphony Hall located in downtown San Diego. Approximately 215 graduating students will receive Juris Doctor degrees.

Kimberly Roth, graduating Summa Cum Laude will be addressing the audience as Valedictorian. "I'm really excited to be Valedictorian of my graduating class," said Roth. "It means all of my hard work over the past three years paid off! These past three years have flown by, but I am eager to graduate, pass the bar, and enter the real world!"

In addition to tutoring and mentoring other law students, Roth currently interns at the Attorney General's Office. She has previously interned for Disability Rights California and for the San Diego County Office of the District Attorney.

During her time in law school, Roth served as Editor for Thomas Jefferson's Law Review and Vice Chair of TJSL's Moot Court Competition Team – which Roth describes as representing some of her most memorable experiences at TJSL. "Our team is like a family to me and I have thoroughly enjoyed working hard for competitions with my fellow teammates," she said.

"I was fortunate to take classes with some of the best professors around that were enthusiastic about the subjects they taught, happy to be teaching, and willing to go out of their way to see their students succeed," said Roth – who credits Professors Susan Bisom-Rapp, William Slomanson, Aaron Schwabach, Marybeth Herald, Julie Greenberg, Anders Kaye, K.J. Greene, Jane Seigel, Carmela Simoncini and Paul Spiegelman, for helping her develop her research, writing, and oral advocacy skills.

"I owe a huge *thank you* to everyone that helped me to be successful in law school. Most importantly, I would not be where I am today without the continuous love and support from my parents, sister, and friends. Their encouragement helped me work hard and push through the late study nights at the library and all-nighters at Lestat's Coffee House," added Roth.

The doors will open at 9 a.m. at <u>Copley Symphony Hall</u>, 750 B Street, San Diego. The graduation ceremony starts promptly at 10 a.m.

The Spring 2014 commencement speaker is Board of Trustees member Judge Roger Benitez '78. The Honorable Roger T. Benitez was first appointed to the Superior Court of California in 1997, after previously working in general practice with a law firm. He served as Presiding Judge of the Appellate Division before being appointed as a United States Magistrate Judge for the Southern District in 2001. In 2004, he was appointed to the District Judge position he now holds. Judge Benitez has sat by designation numerous times with the Ninth Circuit Court of Appeals and also has sat on assignment in Arizona, Guam and Saipan. He is a charter member of the Wallace Inn of Court, currently chairs the Southern District's IT Committee and is a member of the U.S. Judicial Conference Committee on Financial Disclosure, having been appointed by Chief Justice John Roberts.
