“It feels amazing,” said graduate Shahram Mangoli.” It’s all coming to an end, but at the same time, I feel that life is just beginning.”

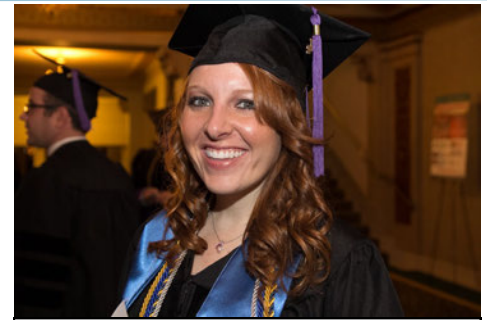

"I stand as a proud graduate of TJSJ," said commencement speaker Vince Hall '08, the newly appointed Chief of Staff to San Diego's new mayor, Bob Filner. Hall personifies the career possibilities of those with law degrees. "A significant percentage of our graduates have had successful careers outside of law," said Hall, who until recently was the Vice-President of Public Affairs & Communications at Planned Parenthood of San Diego & Riverside Counties, and has served on the staffs of such politicians as then congressman Filner and former California Governor Gray Davis.

"A law degree helps you understand the foundation of society and we are a nation of laws. A legal education stretches your mind and makes you see the world in new ways, no matter what profession you choose."

Hall spoke of the difficult job market some of the graduates face if they are not already employed when he urged, "Take charge of your future. Your job search is the toughest job you will ever have. So be the toughest and best boss you'll ever have during your job search. Unemployment is not a cause of action, but a cause for action."

TJSL's Amy Louttit 3L Honored at Lawyers Club of San Diego Holiday Luncheon

Amy Louttit stood proudly as the TJSL student accepted the Lawyers Club of San Diego Women and the Law Project at Thomas Jefferson School of Law Scholarship at the Lawyers Club's 30th Annual Holiday Luncheon on December 13th, a very festive occasion for all who attended.

"It is my distinct honor to get to introduce you to her today," said TJSL's Associate Dean Beth Kransberger. "As legal educators, we are often privy to moments of transcendence and magic as we provide opportunities for others. I am delighted to say this is one of those transcendent moments for me today."

Louttit, who is going into her third year of law school, has spent many years working with put-at-risk kids and says she has never really been recognized for any of her accomplishments.

Today was the day. She received a \$2,000 scholarship from TJSL to help with the expense of tuition and books. Louttit joins TJSL alumni Catrina Skor '11 and Elizabeth Knowles '12 as recipients of this scholarship award.

As she spoke to the large audience, Louttit said. "It is really exciting to be able to recognize my own support group here." She especially singled out TJSL Professor Joy Delman, whom she considers a mentor.

"She made me cry," said Professor Delman. "While I'm honored to serve as Amy's mentor, her passion and her success at such an early stage in her career serve as an inspiration to me! I am grateful to have a student who is not just learning law, but applying it in real-life situations that help those who need her services. She is extraordinary."

Louttit says she is honored to receive the scholarship, and her pride is justifiable after the difficult road she traveled to reach law school.

"It feels really good, said Louttit. "I've overcome a lot to be here. I've had good female role models, especially teachers, who have encouraged me to have the strength and independence to have confidence in myself. I came to California alone at age 17, after leaving a difficult household situation in South Carolina. I graduated from high school a year early, and then went to Humboldt State. I served two years with AmeriCorps and I fell in love with the homeless kids I worked with there. I developed amazing bonds with some special kids."

Louttit refers to her internship at the National Association for the Education of Homeless Children and Youth as "my dream job!" She also serves as the Event Chair for TJSL's Law Students for Reproductive Justice student organization.

Thomas Jefferson School of Law established this annual scholarship in collaboration with Lawyers Club of San Diego, a non-profit specialty bar association seeking to advance the status of women in the law, to support and improve the administration of justice and to promote equality of women and men in our society. The scholarship is awarded to a TJSL student in good standing who demonstrates support of the mission of Lawyers Club and is academically among the top 50% of his or her law school class.



Frank J. Terrazas 3L Awarded The Bonnie Reading Memorial Scholarship!

Third year student Frank J. Terrazas accepted the Bonnie Reading Memorial Scholarship on November 16, 2012 at the annual Norby Awards Dinner, which was held in the Ballroom at the San Diego County Bar Association.

The Bonnie Reading Memorial Scholarship is awarded by the Certified Family Law Specialists Committee of the San Diego County Bar Association (SDCBA) to a law student who shows dedication and commitment to the area of family law and plans to practice family law in the San Diego area.

For the last six years, Terrazas has worked as a paralegal for Stanwood Johnson, CFLS and has helped organize several Family Law CLE Seminars. Not only has his knowledge in family law expanded, but he currently makes appearances as a Certified Law Student.

“I never thought I would enjoy family law but it has found me and I see the huge potential to develop as a litigator, which has always been my focus, and to connect with your clients better” said Terrazas.

Terrazas attributes this recognition to his family law coursework and being active in the family law section of the SDCBA. “It is a very prestigious award within the local family law bar,” said Terrazas. “The scholarship is awarded to only one law student in the county and I beat out over 30 applicants from the area law schools.”

Terrazas plans to open a solo practice in San Diego after graduating and passing the bar. “It is extremely rewarding to help guide a client through one of the most difficult times in their lives,” he explained.

Summer Judicial Internship Opportunities For Diverse Students

The goal of the Judicial Resources Committee and Just The Beginning Foundation’s Third Annual Summer Judicial Internship Diversity Project is to provide summer judicial internships for highly qualified minority, underrepresented, and economically disadvantaged law students. This is a national program that will place 75 students as judicial interns in federal appellate, district, bankruptcy, and magistrate judges’ chambers across the country. Interns will have the opportunity to draft bench memoranda, judicial orders, and opinions on a variety of substantive matters, including motions to dismiss, motions for summary judgment, magistrate judge reports, and habeas corpus petitions. Applicants should possess strong research and writing skills and be prepared to handle the rigors of working in a federal court.

Associate Dean William Byrnes Announces New Publications

TJSL's Associate Dean William Byrnes has announced the publication of two new books and updated supplements to two of his earlier publications.

On December 11, Lexis released the 400 page quarterly supplement for *International Withholding Tax Treaty Guide* (Release 133, December 2012). "This supplement nearly completes my re-write process of this book to re-structure the citation architecture for a modern approach to tax treaty analysis," said Dean Byrnes. "Over the next two years, I will author an in-depth, comparative analysis of tax treaty articles, to provide practitioners and arbitrators a go-to treatise for global corporate planning."

On December 12, Wolters Kluwer released *International Trust Laws & Analysis*, the 4th supplement of 2012. "This year, our focus was to complete the analysis of the company law for 40 countries. With this final supplement of 2012 we returned to the trust law aspects, focusing on such jurisdictions as Australia, China, Hong Kong, Ireland, Gibraltar to name a few, as well as updates regarding the Hague Convention. In 2013, my attention will turn to comparatively address issues with investment funds, and offering of financial products to the public," said Dean Byrnes.

Both publications are co-authored by Associate Dean William Byrnes and Dr. Robert J Munro.

In November, National Underwriters released two tax books: *Tax Facts on Investments* (2013), and the 2 volume *Tax Facts on Investments & Employee Benefits* (2013), co-authored by Associate Dean William Byrnes and Robert Bloink. "These market leaders mark a milestone of a major re-organization of material for ease of research and understanding, also," Dean Byrnes said. Also I have included a new section on captive insurance, on reverse mortgages, as well as expanding the section on ETFs and on precious metals & collectibles." Both publications are now available as e-books, as an alternative or in combination with print.

Academic Success is now accepting applications for spring semester ASP Mentors

What do ASP Mentors do?

ASP Mentors are second and third year students who work with small groups of students enrolled in 1L courses, providing skill-based support and guidance to assist the mastery of legal doctrine. ASP Mentors do this by monitoring and facilitating Structured Study Groups, which use cooperative learning techniques. ASP Mentors help 1L students demonstrate subject mastery, learn test-taking skills, and practice exam writing. With the guidance of ASP Mentors, students in Structured Study Groups can better determine how well they are doing and where they need help.

Who can be an ASP Mentor?

ASP Mentors must have successfully completed all first year courses for which they are providing support and must be in good academic standing. ASP Mentors must either be eligible to receive Federal Work Study or to receive Jeffersonian Scholar funds.

Why be an ASP Mentor?

ASP Mentors have the unique opportunity to share their own knowledge and skills with other students. This not only contributes to the TJSL community, but it also affords ASP Mentors the opportunity to keep their own doctrinal knowledge and legal skills sharp, in preparation for the bar exam and for practice. ASP Mentors are paid for the time they spend attending training sessions, preparing for Structured Study Group meetings, and facilitating their small group meetings.

What is the time commitment?

ASP Mentors are expected to attend training through the Academic Success department, to meet weekly with small groups of students in Structured Study Groups, and to report regularly to ASP.

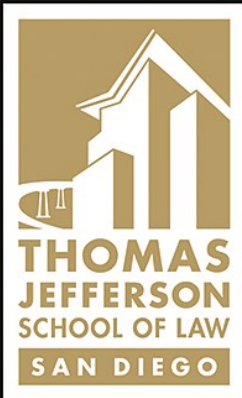



