



VITA Tax Clinic is Open for 17th Season of Free Tax Return Services

From now until April 12, the Volunteer Income Tax Assistance (VITA) program operated by Thomas Jefferson School of Law's Tax Law Society, a student organization, will provide free income tax return preparation for students, low-income families, senior citizens and others who can't afford professional tax services or are unable to complete their own tax forms.

Since 1998, TJSL students have annually offered this service to the San Diego community. The clinic's student volunteers

receive training to become IRS-certified, operate the TaxWise software, interview clients effectively and assemble a proper tax return.

The TJSL tax clinic is open to walk-in clients on Tuesdays and Thursdays from 3-7 p.m.

The Tax Law Society is advised by TJSL Professor Richard Winchester, a former attorney in the national tax office of PricewaterhouseCoopers, who is a national authority on employment tax policy and the taxation of closely held businesses.

The tax clinic is located in the Law Clinic office at the Thomas Jefferson School of Law in the East Village area of downtown San Diego.

Items you need to bring to the TJSL Tax Clinic to have your tax returns prepared are:

- ◆ Proof of identification
- ◆ Social Security Cards for you, your spouse and dependents and/or a Social Security Number verification letter issued by the Social Security Administration
- ◆ Wage and earning statement(s) Form W-2, W-2G, 1099-R, from all employers
- ◆ Interest and dividend statements from banks (Forms 1099)
- ◆ A copy of last year's Federal and State returns if available
- ◆ Bank Routing Numbers and Account Numbers for Direct Deposit
- ◆ Total paid for day care provider and the day care provider's tax identifying number (the provider's Social Security Number or the provider's business Employer Identification Number)
- ◆ To file taxes electronically on a married filing joint tax return, both spouses must be present to sign the required forms.

Students Gain Legal Writing Tips From Judge Benitez and Judge McCurine, Jr. (Ret.)

TJSL Board of Trustees members Hon. Roger T. Benitez '78 and Hon. William McCurine, Jr. (Ret.) shared their perspectives on the importance of legal writing skills with students at "A View from the Bench," a panel hosted by Thomas Jefferson School of Law's Legal Writing and the Clinical Externship and Pro Bono Programs on Saturday, March 8th.

"I really appreciate the judges taking the time to speak with us," said Paul Hefley (3L). "In terms of written briefs filed with the court, judges are the end users of an attorney's work product so getting their unique perspective of what works and what doesn't work in legal writing was priceless."

The judges shared their expectations from the bench and cautioned students on specific things to avoid. Some of the judge's pet peeves were incorrect citations, hiding contrary authority, using string citations, cutting and pasting without knowing the case law and creating false facts. "We depend on good lawyers to tell us what the law is," said Judge McCurine.

"I thoroughly enjoyed what Judge Benitez had to say about the importance of writing and submitting to the court, and how brevity is key," said Johnathan Stahler (3L).

In addition to writing tips, students also gained valuable insights from the judges on being young practicing attorneys from the judge's personal stories. "As a young lawyer the most important thing is learning how to manage your time, while still putting out good work product," said Judge Benitez.

"Judges are always held on such a high level that sometimes I feel as if they are not accessible, but these two Judges were really down to earth and had some funny and valuable war stories. I enjoyed the presentation very much," said Lucia Valenzuela (2L).

The judges also shared their unique perspectives on the legal profession. "Judge Benitez explained that lawyers are in the 'sales business' and that as lawyers we sell through our words by having concise and clear language," said Ricardo Elorza (2L).

Stephanie Ferguson (3L) and Stuart Mellman (3L), attended the event and shared their perspectives on clerking for Judge Benitez this semester. "Working as a judicial extern for Judge Benitez has been a tremendously valuable experience because it has provided me with the opportunity to expand the scope of my legal education," said Mellman. "I have conducted legal research and writing on new subject matters and continue to hone my writing abilities."

"This has been one of my most rewarding experiences during law school for two reasons. First, my legal writing has greatly improved as a result of the unparalleled feedback from the law clerks, and second, I have a greater appreciation and respect for the legal profession and the Federal court system," said Ferguson. "From witnessing criminal sentencing hearings to patent claim construction hearings, I am constantly provided with unique opportunities which allow me to fully analyze and appreciate the nuts and bolts of litigation from both sides of the bench," she added.

During her time in law school, Roth served as Editor for Thomas Jefferson's Law Review and Vice Chair of TJS�'s Moot Court Competition Team – which Roth describes as representing some of her most memorable experiences at TJS�. "Our team is like a family to me and I have thoroughly enjoyed working hard for competitions with my fellow teammates," she said.

"I was fortunate to take classes with some of the best professors around that were enthusiastic about the subjects they taught, happy to be teaching, and willing to go out of their way to see their students succeed," said Roth – who credits Professors Susan Bisom-Rapp, William Slomanson, Aaron Schwabach, Marybeth Herald, Julie Greenberg, Anders Kaye, K.J. Greene, Jane Seigel, Carmela Simoncini and Paul Spiegelman, for helping her develop her research, writing, and oral advocacy skills.

"I owe a huge *thank you* to everyone that helped me to be successful in law school. Most importantly, I would not be where I am today without the continuous love and support from my parents, sister, and friends. Their encouragement helped me work hard and push through the late study nights at the library and all-nighters at Lestat's Coffee House," added Roth.

The doors will open at 9 a.m. at [Copley Symphony Hall](#), 750 B Street, San Diego. The graduation ceremony starts promptly at 10 a.m.

The Spring 2014 commencement speaker is Board of Trustees member Judge Roger Benitez '78. The Honorable Roger T. Benitez was first appointed to the Superior Court of California in 1997, after previously working in general practice with a law firm. He served as Presiding Judge of the Appellate Division before being appointed as a United States Magistrate Judge for the Southern District in 2001. In 2004, he was appointed to the District Judge position he now holds. Judge Benitez has sat by designation numerous times with the Ninth Circuit Court of Appeals and also has sat on assignment in Arizona, Guam and Saipan. He is a charter member of the Wallace Inn of Court, currently chairs the Southern District's IT Committee and is a member of the U.S. Judicial Conference Committee on Financial Disclosure, having been appointed by Chief Justice John Roberts.

TJSL Students Visit the Intertribal Court of Southern California

Members of TJSL's Native American Law Students Association (NALSA) got a rare opportunity to visit the Intertribal Court of Southern California (ICSC) located on the Rincon Indian Reservation on February 26.

Though ICSC is located in Valley Center, California, tribal judges often travel between member tribes to preside over cases using tribal laws, ordinances, customs, and historical precedence. The ICSC is an independent judiciary within Indian Country to preserve the integrity, autonomy and self-governance of the tribes it serves. The Tribal Judicial Council of Southern California oversees the administration of the Court under the Intertribal Governing Agreement between the following member tribes: The Jamul Indian Village, Los Coyotes Band of Mission Indians, La Jolla Band of Luiseño Indians, Manzanita Band of the Kumeyaay Nations, Mesa Grande Band of Misison Indians, Rincon Band of Luiseño Indians, San Pasqual Band of Indians, and the Santa Ysabel Band of Diegueño Indians.

“Visiting the Intertribal Court brought tribal sovereignty to life, said NALSA President Monique Rodriguez (3L). “It was amazing to see Indian law working at its best and the respect & empowerment the Indian community has in the system they created.”

During their visit, students had the opportunity to view appellate oral arguments and meet privately with the Hon. Anthony Brandenburg '79 and Hon. John Madigan '91. “It was absolutely fascinating to watch oral arguments before an Appellate Court inside Indian Country,” said NALSA's Vice-President Samantha Morales (3L). “As a young scholar in the field, I found it extremely valuable and inspiring to speak one on one with Chief Judge Brandenburg and Judge Madigan.”

“The most exciting part of the trip was being able to chat with TJSL alumni Judge Madigan and Judge Brandenburg about current issues pertaining to Native American law,” said Kawika Kaulukukui (1L). “What stood out was when Judge Brandenburg talked about how the tribal court decisions are based on both traditional Native American customs and modern laws.”

“I found the sensitivity of the judges to be refreshing,” said Ruby Faagau (1L). The judges emphasized the importance of empathy and respect in dealing with the Native members of the various tribes. The court itself provides a forum for the original inhabitants of this land - who are marginalized today - to be heard and seen.”

“NALSA is very excited that we were invited to the court and we hope to maintain a connection,” said Rodriguez.

With the re-chartering of NALSA last year, TJSL is now the only law school in San Diego to have an active NALSA chapter that is a member of the National NALSA. TJSL is also the only law school in San Diego to offer a course on American Indian Law taught by Professor Bryan H. Wildenthal, who is widely published in the field.

TJSL Student to be Published in Family Law Journal

Second-year TJSL law student Kimberly Coulter recently accepted an offer to be published in next year's issue of the Whittier Journal of Child and Family Advocacy.

Coulter's article, "A Shift from Incidental to Instrumental: A Promise of Stability When Stepparents Have Been a Primary Source of Parenting Support" advocates for giving residential stepparents automatic standing and a voice in custody and visitation hearings following a passage of a rigorous parenting test.

"I am deeply proud and humbled by the honor of being published," said Coulter – the 2013 recipient of the Lawyers Club Women and the Law Project at Thomas Jefferson School of Law Scholarship.

Coulter's interest in family law is rooted in her previous work as a teacher in inner city schools and as a mother raising three young children. "Since the subject of my Note touches my life very personally, it is truly a labor of love as my husband is a devoted stepfather to our children, yet simultaneously he is a legal stranger to them," shared Coulter.

"I am grateful for the offer of publication because it means that many others will have the opportunity to read my arguments and consider their merits," she said.

The Whittier Journal of Child and Family Advocacy publishes one issue each year. Coulter's paper will be cite checked and peer-reviewed during the 2014-2015 school year and published in the 2015 issue.

Professor Bisom-Rapp Appointed to Scientific Committee of an Italian Foundation

Professor Susan Bisom-Rapp has accepted an invitation to join the Scientific Committee of the Marco Biagi Foundation in Modena, Italy. The offer of this prestigious appointment was extended on behalf of the Governing Board of the Marco Biagi Foundation by Marina Biagi, who serves as the Foundation's President.

Part of the University of Modena and Reggio Emilia, Italy, the Marco Biagi Foundation is home to the International Doctoral Research School in Labour Relations, which offers PhD studies

in labor and employment relations that are comparative and interdisciplinary. The Foundation also hosts conferences and symposia. A highlight of its programming is the annual comparative labor law conference held to commemorate the life and work of Professor Marco Biagi, a noted legal scholar.

The Scientific Committee is the Foundation's academic advisory board. Dr. Iacopo Senatori, the Secretary of the Foundation, describes the work of the Scientific Committee this way:

[I]n broad terms, the Scientific Committee's task is to provide advice on the scientific activities carried out by the Foundation (research projects, conferences, publication of books, educational programmes etc). The Scientific Committee can be activated by the Foundation's President, Marina Biagi (who also chairs the Committee) and operates upon impulse from the Foundation's Administrative Board.

"I am deeply honored to be invited to join the Scientific Committee," said Professor Bisom-Rapp. "For many years, I have considered the Foundation to be my home-away-from-home," she noted. "I look forward to increasing my engagement with the Foundation, and to making a positive contribution to its scholarly work."

Professor Bisom-Rapp has served on the Foundation's International Council since 2009. She will continue to serve on the Council, which meets once a year and provides advice on various curricular issues. Professor Bisom-Rapp will also continue to help organize and serve as a commentator for the Foundation's annual Young Scholars' Workshop, which features outstanding papers written by PhD candidates from around the world.

Indeed, she is headed to Modena, Italy for spring break, and has a busy schedule at the Foundation, which includes giving a lecture to the Foundation's PhD students, chairing a panel at the annual conference, commenting at the Young Scholars' Workshop, and attending several meetings. This will be Professor Bisom-Rapp's eighth consecutive year attending the annual March events at the Foundation.

Professor Bisom-Rapp is an internationally known scholar in the field of comparative workplace law, who writes about globalization, equal employment opportunity, occupational safety and health, and the rights of migrants.

Professor Bisom-Rapp regularly teaches a seminar on international and comparative employment law at Thomas Jefferson School of Law.

The seminar uses her co-authored casebook, *The Global Workplace (2d. ed. 2012)*, the only course of its kind offered in Southern California.

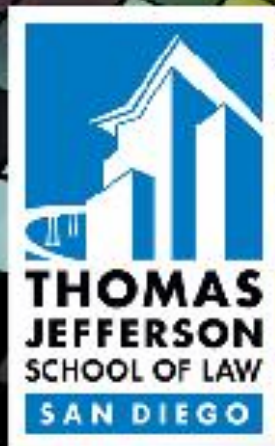
Professor Luz Herrera Named One of San Diego's 2014 Young Influentials

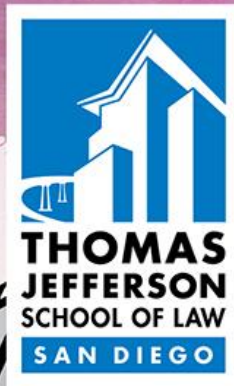
