

## ADR Team Effort Adds to TJSL'S Remarkable Record in the California Bar's Environmental Negotiation Competition

The TJSL team of Sean Kelley 2L and Lawrence Kleinman 3L, ably coached by Patrick Downing 3L and Khoulood Elmasari 2L, won second place and a \$500 prize in the 13<sup>th</sup> Annual California Bar Environmental Negotiation Competition held in San Francisco on March 15. This continued TJSL's remarkable record of six final four appearances in the 13 years of the competition with two wins, three seconds and one fourth.

In this year's competition Shawn Kelley and Lawrence Kleinman beat 18 other teams, including teams from UC Berkeley, UC Davis, UC Hastings, UCLA, California Western, Golden Gate, Loyola, Santa Clara, USF and Western State. Also competing strongly for TJSL were Michael Morphew and Timothy Thiel, ably coached by Yvonne Ruiz and Rachel Wechhorst Espejo. They narrowly missed the final four.

The second place finish for Kelley and Kleinman was truly a team effort. They spent six weeks preparing for the competition, drilled by their coaches Patrick Downing and Khoulood Elmasari and sparring with a wide array of the ADR team members. They practiced in a "fishbowl" in front of the entire team and got instant feedback from the whole ADR team.

The problem they negotiated was based on the water issues in California's Delta, where the farmers and residents from northern and southern California vie for water supplies and where 80% of California's rain falls but where only 20% of its population lives. Professor Spiegelman, the faculty advisor to the ADR team, said it was by far the most complex problem set he had seen in any competition over the many years has been coaching student negotiation team.

When they reached the final four, Kelley and Kleinman had one hour and 15 minutes to prepare a problem that was five single-spaced pages involving the paring down of a bond proposal from \$10 billion to \$7 billion. The bond issue involved six separate project titles and the parties had differing priorities on almost all of them. The team operation went into gear. Kelley, Kleinman and Professor Spiegelman developed a strategy and system for presenting and moving on the numbers, Downing and Elmasari developed bullet points for the subject matter and priority of each project title, and Thiel and Wechhorst put together a list of the monetary ranges the team was authorized to agree to for each title. While the team members put the final touches on their preparation, Professor Spiegelman attended a conference on any possible clarification of the facts. The judges commented on the amazing grasp of the problem the negotiators had.

"Although we have done well in many competitions over the years, this one stands out as the result of the most collaborative effort I have ever seen. Sean Kelley and Lawrence Kleinman performed extremely well and came up with innovative approaches to the problems, but they would not have accomplished what they did without the insightful and assertive coaching from Patrick Downing and Khoulood Elmasari; the support and friendly competition from Tim, Mike, Rachel and Yvonne; the feedback from the rest of the team; and the all-around positive vibe of this year's ADR team," said Professor Spiegelman.

"The prospects for the ADR teams future are extremely bright with a very talented group of returning members and a solid base of experience and success to build on for next year."

## Street Law Students Visit Thomas Jefferson

On Friday, March 15, students from ALBA Community Day School came to Thomas Jefferson to tour the campus and sit in on Professor Ben Templin's Contracts II class. ALBA students are a part of this year's Street Law Program at TJSJL.

## Avoiding the State Bar Discipline System: A Workshop

"We see a lot of good people do bad things," said Kristin Ritsema, who appeared at TJSJL on Friday, March 15, for an MCLE presentation by TJSJL's Center for Solo Practitioners called "Avoiding the State Bar Discipline System."

Who better to explain it than Ritsema? She is the Supervising Senior Trial Counsel of the state bar's Office of Chief Trial Counsel. She tries attorney disciplinary cases in the State Bar Court, but as she said, their "favorite thing is to not have to prosecute."

Disciplinary violation outcomes range from disbarment to suspension to merely a letter of warning. Some attorneys even have to attend "ethics school."

According to Ritsema, the best way to avoid the bar's discipline system is to "know what your ethical obligations are." She listed several sources and said the [California Rules of Professional Conduct](#) are required reading for all attorneys. "If you know the rules, you're not likely to violate them," Ritsema said."

Ritsema also said the [State Bar Act](#) of the Business and Professions Code ( B&P Code §§, et. Seq.) is important, as is keeping up with case law from both the California Supreme Court and the State Bar Court Review of Department cases.

Two of the most common disciplinary violations, according to Ritsema, are failure to keep your client advised of significant developments and failure to respond to your client's inquiries on the status of their case as there is a duty to keep the client informed under the Business and Professions Code. (B&P Code § 6068 (m) ). One way to avoid that problem is to "shoot a copy to the client of all the correspondence you write and motions you file," she said.

Another violation Ritsema cited is failure to act with competence. One example she gave is a client who walks into your new solo practice office with a huge potential class-action suit. She said you have to ask yourself, "Do I have the competence and the resources to handle this case." She says one option you have is to associate yourself with a large firm to handle the case because "that way you stay involved."

Another rule that is often broken is what Ritsema called The Golden Rule – "The case file belongs to the client. If you take nothing else away from this presentation today, that is the most important thing. You can't hold the client's file hostage – even if they haven't paid you."

Ritsema also went over the rules of handling Client Trust Accounts. Co-mingling funds and misappropriation of funds are two of the most common CTA violations.

"Mistakes happen, but is it willful misconduct?" Ritsema stressed, in explaining one of the most important questions she and her colleagues ask whenever a potential case is referred to them.

"We are fortunate to have access to an experienced attorney from the state bar give us insight about how her agency vies and handles complaints against attorneys," said TJSJL Professor Luz Herrera, who founded the Center for Solo Practitioners. "Our students, alumni and staff who attended were equipped with practical information they can use throughout their career."

"The MCLE offered concrete, practical guidance regarding what pitfalls to avoid that could get you in trouble with the State Bar Discipline System. It's one thing to refer you to the rules of professional conduct," said attorney Alara Chilton, who practices criminal defense and consumer litigation. "It's quite another to inform you of how the discipline system works, what you can do if someone files a complaint, and the procedures you can implement to help comply with your ethical obligations. I am most grateful to TJSJL and its Center for Solo Practitioners for putting on this terrific program."

After the discipline workshop, the Center for Solo Practitioners held an intensive training for its New Solos on how to handle client trust accounts. This is an area of law that is often confusing and difficult for lawyers. According to Professor Herrera, "Ms. Ritsema helped us better understand the resources the bar provides to help lawyers navigate this critical part of their practice."



## TJSL Alumni Association Presents Networking DOs and DON'Ts

Networking is one of the most important tools of the trade when it comes to getting established in the legal profession. But as those students who attended the TJSL Alumni Associations Networking Dos and Don'ts event at the law school on March 14 learned – networking is both an art and a science.

The three panelists were TJSL alumni who each networked successfully to launch their own careers: Lacy J Lodes '08; Eric Ganci '08 and Jeremy Evans '11. The emcee was Alumni Association President Renee Galente '08.

The consensus was: Don't just walk up to someone at a networking event, stick a resume or business card in their hand and ask for a job. It won't work. In fact, Eric Ganci thinks that's one of the biggest "don'ts."

"Networking makes genuine connections," said Lacy J Lodes. "It won't necessarily get you a job, but it does allow you to plant the seeds. To get a job, you need to be around the people you want to work with and look up to. Instead of asking for a job, ask for advice on getting a job."

And Lodes stressed getting involved with both legal organizations as well as non-legal organizations, such as business associations.

"Network early and often," said Eric Ganci. "What Lacy J said is the goldmine. Get involved with legal organizations outside of law school. It gives you more contacts when you get into practice. Also, meet lawyers in the fields you're interested in. Take them out to coffee. Learn what their typical day is like."

"Where your heart is is where you'll find your treasure," said Jeremy Evans, speaking of the importance of knowing exactly what you want to do with your JD degree. He added that, "Professionalism starts the first day of law school."

The panelists also said it's not just getting to know others, but letting them get to know you. At networking events it's quality, not quantity. You can't get to know everyone at a networking gathering, but you can get to know several people by having good conversations with you that they will remember.

One good piece of advice they offered: "try to get information, not a job." Another piece of advice: "Always have business cards with you."

And Lodes is a big believer in thank yous. "I got a job offer from an interviewer who didn't treat me very well. But I had sent her a thank you card, and she said that's why she hired me."

There were networking opportunities for the students at the event itself. Several legal organizations from the San Diego legal community had representative attorneys in attendance, who graciously and enthusiastically gave of their time. He added that people you network with need to know who you are, where you're coming from and what you want to do. "Nobody cares about how much you know until they know how much you care," he said.

## TJSL Opening a Veterans Self-Help Legal Clinic This Week



Thomas Jefferson School of Law will open a Veterans Self-Help Legal Clinic this Wednesday, March 20, to help former military service members with their legal needs. The veterans will be assisted by volunteer lawyers from the community working side-by-side with TJSL law students.

The self-help clinic will be appointment-only and will operate the third Wednesday of every month from 6:00 – 8:00 p.m. at 495 Eleventh Avenue. The clinic is now taking appointments.

“San Diego is home to more recently returned veterans from Iraq and Afghanistan than any other city in the country,” according to the clinic’s director, Professor Steve Berenson. “Many of them are grappling with a variety of legal issues without the assistance of counsel. The new clinic is designed to provide as much help as possible to these struggling veterans to represent themselves successfully in their legal matters. The clinic will also provide an additional opportunity to students at TJSL to get hands on legal practice experience, work with established volunteer lawyers and serve the San Diego community.”

On March 6, Professor Berenson presented a training session for the volunteers who will be staffing the self-help clinic – both attorneys and law students. The class focused on the substantive issues that are likely to arise in the clinic. [The class can be viewed online](#).

“The class went very well,” said Professor Berenson. “We had some of the top practitioners in San Diego presenting on issues that are likely to be prevalent among the veterans seeking services from the clinic. They included former VLAC Fellow Tiffany Gilmartin ’10 addressing family law issues; Patrick Long ’10 discussing veterans benefits; Susan Clemens ’85 addressing offender reentry issues; and Michael O’Halloran discussing bankruptcies. We also had Steve Binder ’84 from the Public Defender’s office discussing his experience in nearly three decades of working with struggling veterans here in San Diego.”

Each appointment at the Veterans Self-Help Clinic includes a half-hour consultation with a licensed attorney and a law student, who will provide limited assistance only, and not full or ongoing legal representation.

A number of important self-help services are available to veterans.

- Document Assistance: Help with filling out forms to be submitted to the court.
- Computer Access: The computers will be available to assist with filling out legal forms and conducting legal research.
- Document Review: Pre-filled out forms will be reviewed prior to submitting them to the court.
- Additional Resources: Information on how to move forward with your case.

Since 2006, TJSL has operated a highly successful Veterans Legal Assistance Clinic at Veterans Village of San Diego (VVSD). Our law students have been specially trained to work with VVSD’s residents on with their many legal issues.

This new Veterans Self-Help Clinic expands the law school’s commitment to help our country’s veterans with the many legal issues they may also face.

The Public Law Section is seeking entries for its annual Student Writing Competition. In addition to the cash prize, the winning entry will be published in the Public Law Journal. Articles should pertain to one of the following topics: Administrative Law; Constitutional Law; Municipal Law; Open Meeting laws; Political/Election Laws; Education Law; State and Federal Legislation; Public Employment and Labor Law; Government Contracts; Government Tort Liability and regulations; Land Use/Environmental issues; Public Law Ethics; or Public Finance. Articles must be submitted and written by a student enrolled as of May 13, 2013, in good standing at a California law school's Juris Doctor program that is accredited by the Committee of Bar Examiners of the State Bar of California.

The article must be submitted in a format suitable for publication in the Public Law Journal. The article should be the original work of the submitting student without substantial editorial input from others. A student need not be a member of the Public Law Section to participate in the writing contest.

Articles should have a minimum of 2,000 words and a maximum of 3,000 words (not including endnotes). Articles should include citations in either Bluebook or California Style Manual format, and citations must be included in endnotes, not footnotes.

**AWARD**

The author of the winning student article will receive a \$2,000 cash prize from the Public Law Section and will have his or her article published in the Public Law Journal. The winner also will be recognized at the Ronald M. George Public Lawyer of the Year Award reception sponsored by the Public Law Section at the State Bar's Annual Meeting in September 2013. The Public Law Section will pay the winner's reasonable transportation and hotel accommodation expenses for two nights to attend the award reception.

**DEADLINE/METHOD OF SUBMISSION**

Articles must be received by midnight (PST) on May 13, 2013 to be eligible for consideration in this writing contest. Please submit articles by email as attached Microsoft Word documents in Times New Roman 12-point font, single-spaced, with one line between each paragraph. Citations must be included in endnotes, not footnotes. 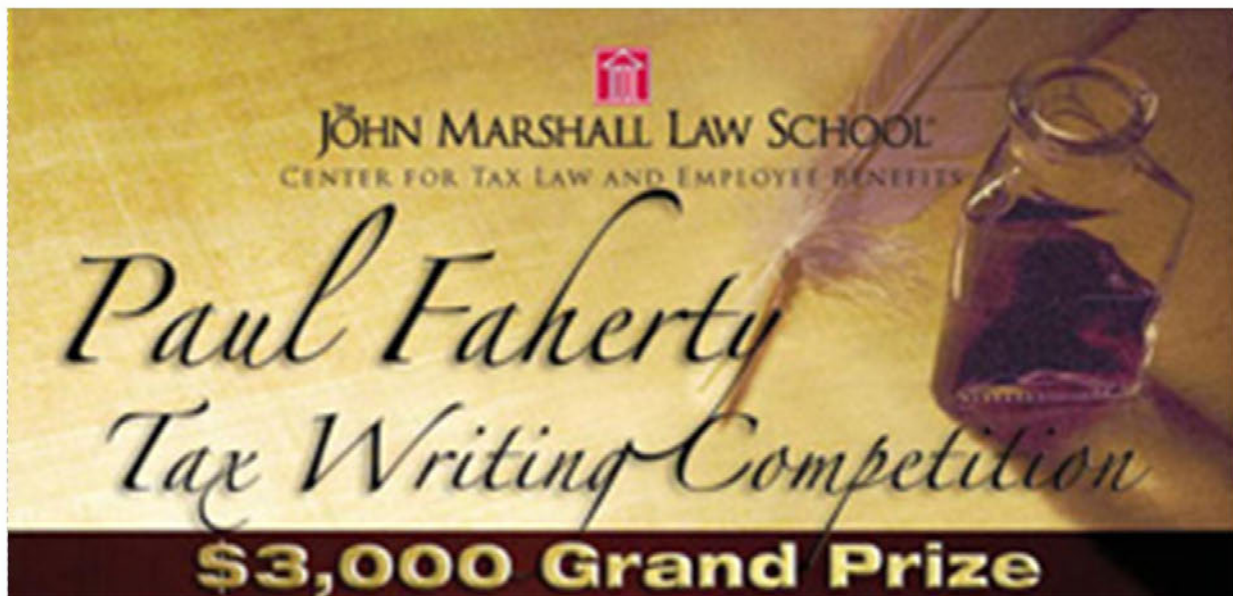
### **Countdown to Final Exams**

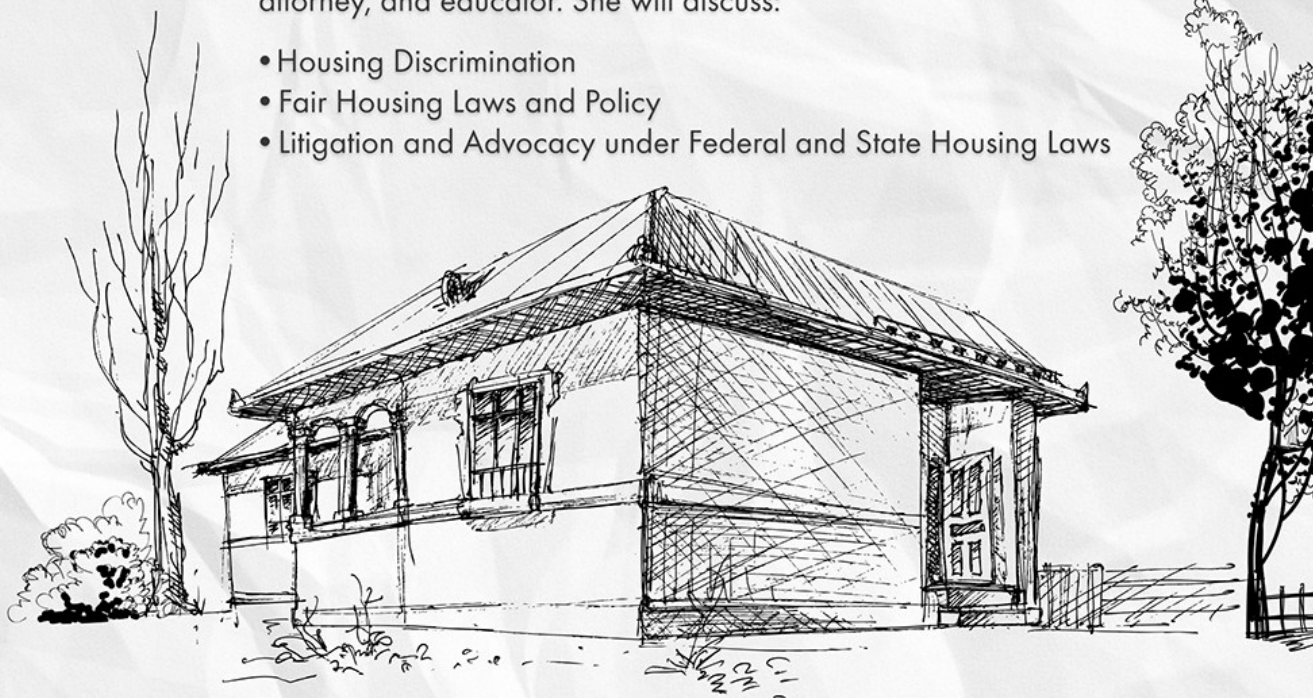

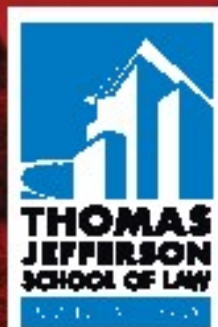
