Thomas Jefferson School of Law's Spring Commencement will be held on Saturday, May 17, 2014, 10 a.m., at Copley Symphony Hall located in downtown San Diego. Approximately 215 graduating students will receive Juris Doctor degrees.

Kimberly Roth, graduating Summa Cum Laude will be addressing the audience as Valedictorian. "I'm really excited to be Valedictorian of my graduating class," said Roth. "It means all of my hard work over the past three years paid off! These past three years have flown by, but I am eager to graduate, pass the bar, and enter the real world!"

In addition to tutoring and mentoring other law students, Roth currently interns at the Attorney General's Office. She has previously interned for Disability Rights California and for the San Diego County Office of the District Attorney.

During her time in law school, Roth served as Editor for Thomas Jefferson's Law Review and Vice Chair of TJSL's Moot Court Competition Team – which Roth describes as representing some of her most memorable experiences at TJSL. "Our team is like a family to me and I have thoroughly

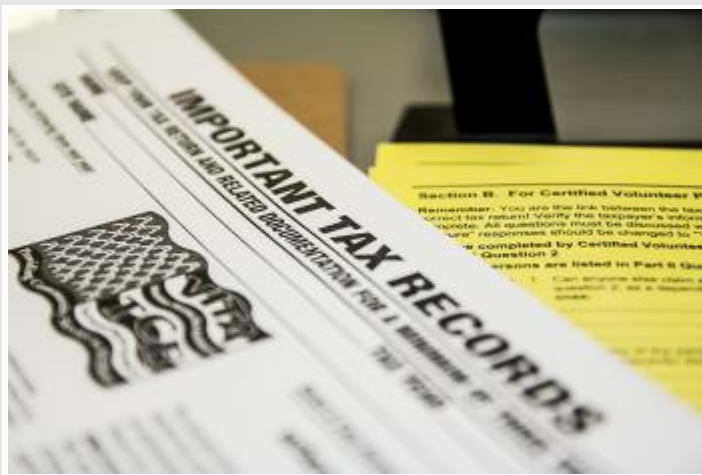
enjoyed working hard for competitions with my fellow teammates," she said.

"I was fortunate to take classes with some of the best professors around that were enthusiastic about the subjects they taught, happy to be teaching, and willing to go out of their way to see their students succeed," said Roth – who credits Professors Susan Bisom-Rapp, William Slomanson, Aaron Schwabach, Marybeth Herald, Julie Greenberg, Anders Kaye, K.J. Greene, Jane Seigel, Carmela Simoncini and Paul Spiegelman, for helping her develop her research, writing, and oral advocacy skills.

"I owe a huge *thank you* to everyone that helped me to be successful in law school. Most importantly, I would not be where I am today without the continuous love and support from my parents, sister, and friends. Their encouragement helped me work hard and push through the late study nights at the library and all-nighters at Lestat's Coffee House," added Roth.

The doors will open at 9 a.m. at [Copley Symphony Hall](#), 750 B Street, San Diego. The graduation ceremony starts promptly at 10 a.m.

The Spring 2014 commencement speaker is Board of Trustees member Judge Roger Benitez '78. The Honorable Roger T. Benitez was first appointed to the Superior Court of California in 1997, after previously working in general practice with a law firm. He served as Presiding Judge of the Appellate Division before being appointed as a United States Magistrate Judge for the Southern District in 2001. In 2004, he was appointed to the District Judge position he now holds. Judge Benitez has sat by designation numerous times with the Ninth Circuit Court of Appeals and also has sat on assignment in Arizona, Guam and Saipan. He is a charter member of the Wallace Inn of Court, currently chairs the Southern District's IT Committee and is a member of the U.S. Judicial Conference Committee on Financial Disclosure, having been appointed by Chief Justice John Roberts.



VITA Tax Clinic is Open for 17th Season of Free Tax Return Services

From now until April 12, the Volunteer Income Tax Assistance (VITA) program operated by Thomas Jefferson School of Law's Tax Law Society, a student organization, will provide free income tax return preparation for students, low-income families, senior citizens and others who can't afford professional tax services or are unable to complete their own tax forms.

Since 1998, TJSL students have annually offered this service to the San Diego community. The clinic's student volunteers

receive training to become IRS-certified, operate the TaxWise software, interview clients effectively and assemble a proper tax return.

The TJSL tax clinic is open to walk-in clients on Tuesdays and Thursdays from 3-7 p.m.

The Tax Law Society is advised by TJSL Professor Richard Winchester, a former attorney in the national tax office of PricewaterhouseCoopers, who is a national authority on employment tax policy and the taxation of closely held businesses.

The tax clinic is located in the Law Clinic office at the Thomas Jefferson School of Law in the East Village area of downtown San Diego.

Items you need to bring to the TJSL Tax Clinic to have your tax returns prepared are:

- ◆ Proof of identification
- ◆ Social Security Cards for you, your spouse and dependents and/or a Social Security Number verification letter issued by the Social Security Administration
- ◆ Wage and earning statement(s) Form W-2, W-2G, 1099-R, from all employers
- ◆ Interest and dividend statements from banks (Forms 1099)
- ◆ A copy of last year's Federal and State returns if available
- ◆ Bank Routing Numbers and Account Numbers for Direct Deposit
- ◆ Total paid for day care provider and the day care provider's tax identifying number (the provider's Social Security Number or the provider's business Employer Identification Number)
- ◆ To file taxes electronically on a married filing joint tax return, both spouses must be present to sign the required forms.

Peter C. Blair '09 Shares His Experience as a Solo Practitioner

Thomas Jefferson School of Law Alumnus [Peter C. Blair '09](#) opened his criminal solo practice in 2013 where he now handles mostly serious and violent felonies, narcotics possession and sales, domestic violence, fraud, and simple misdemeanors such as DUI and petty theft. "I am thankful for my success in my short career as a solo practitioner, and I am determined to secure continued success in the future," said Blair.

"It was an incredibly difficult decision to make. After receiving a decent salary for a number of years, it was daunting not know-

ing when and where the next paycheck was coming from. Thankfully, the decision paid off. I honestly could not have asked for a better start to my practice," he added.

At the beginning of every case, I determine what the best possible result can be and then attempt to do better. "The most exciting/rewarding part about the job is formulating strategies and working to achieve this goal. This is what separates attorneys that get great results, from those that get unbelievable results. It is a strict policy that benefits my clients and ultimately the long-term future of my firm," said Blair.

Blair was originally interested in intentional law during law school. During his first year, he clerked for a sports agent working with athletes and corporate sponsors in the United States, Europe, and South America. He also worked for an entertainment law firm working with local musicians and artists in San Diego dealing mostly with intellectual property and music incorporation before joining a criminal defense firm. "Within a week, I met several clients that were good people, with good families, that were facing very difficult situations. After a few weeks working in the criminal defense, I realized I had found the right career," said Blair.

After law school, he worked as an independent contractor for several different firms – one of which was a top criminal defense firm in San Diego where he worked as an associate for approximately 3 ½ years. Reflecting on his experience there, Blair shared, "I learned valuable lessons and strategies in terms of how to obtain the best possible results for clients. I also learned how to run a successful criminal defense firm. While working at the firm, I handled hundreds of cases, including a number of highly publicized media cases in very serious felony and federal matters."

Blair continued, "I feel very fortunate for the knowledge, education, and experience that I obtained, and I continue to maintain a very good working relationship with that firm. Working at a high volume, high profile firm for a few years provided me with a solid foundation that has enabled me to obtain very good results for my clients in my own firm.

When asked what advice he would give others considering opening a solo practice Blair said, "For anyone flirting with the idea of leaving a steady paying job to go solo, keep in mind that there is always somebody out there working harder and getting better than you at what you do. Work harder than that person, and you'll be fine."

For the recent grads who have passed the bar, Blair added, "Whether you are applying for jobs or are thinking of going out on your own, my advice is the same: Know your place in your legal community. If you are starting to apply to jobs, be aggressive."

So what does that look like? According to Blair, "For many people, 'job search' consists of sitting in their pajamas submitting resumes on Monster.com. Those applications go straight into the trash. Many graduates are content applying to X number of firms per day, sending the same cover letter, and only changing a few sentences depending on "to whom it may concern." It's all they need to do to feel justified in complaining about the economy and job market. You need to be more aggressive in your job search. Go to the firms. Ask to meet the partners. If they are unavailable, which they will be, leave your business card, resume, and a cover letter that is specifically drafted for that firm. If they don't call you back, which they won't, go back a week later. Do this until you get a short meeting. Offer to do work for free. Take small, independent contracting work from a number of different firms if you have to. Do whatever you can to show you are eager and willing to do whatever it takes to work at that specific firm."



Jakgeem Mays '10 Promoted to Legal Affairs Specialist at NBCUniversal

Hard work pays off, and no one knows that better than TJSU alum, Jakgeem Mays '10. After setting a goal to attend law school and transition into television, Jakgeem was recently promoted to the newly created Specialist, Legal Affairs role for NBCUniversal's Cable Entertainment Group. Jakgeem will draft and negotiate various agreements and handle other legal matters (e.g., rights, chain-of-title analysis) in connection with the development and production of scripted and unscripted programming at E!, Esquire Network, Wilshire Studios, Bravo, and Oxygen.

During his 1L year, Jakgeem learned about the T. Howard Foundation Internship Program through career services who encouraged him to apply. A non-profit organization, the T. Howard Foundation is committed to increasing ethnic diversity in the multimedia and entertainment industry. Jakgeem was selected after a competitive interview process and landed a paid internship at 20th Century Fox.

"Fox is known as a difficult studio to get into, so doors began to open for me after that – I clerked at a major immigration law firm and was hired for an internship at SAGAFTRA in the spring of my 2L year." Of career services Jakgeem says, "Whether providing a pep talk or useful information, Career Services helped me from day one. Assistant Dean for Career Services Beverly Bracker saw in me what some days I couldn't see in myself."

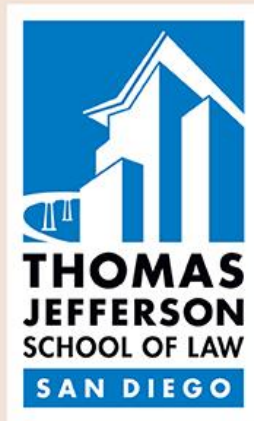
Halfway through law school, Jakgeem made the ultimate sacrifice and moved to Los Angeles after it was stressed to him the importance of taking advantage of networking opportunities in the industry. "While this created many challenges, at the end of the day I was positioned to take advantage of additional internships (Gospel Music Channel, NBCUniversal, etc.) and networking opportunities and eventually one day I got a call to come work in Business Affairs at NBC Entertainment / Universal Television."

Jakgeem is proud of the barriers he has broken to get where he is today. "As a practical matter, NBCUniversal typically hires lawyers from Top 20 law schools. When I first returned to NBCUniversal as a licensed attorney, I was told there was no opportunity for me here." However he continued to pursue his dream, stating that, "Tenacity and perseverance kept me going when I wanted to quit. It's really true what they say – winners do what losers are not willing to do." He is excited to bring his years of experience in entertainment and most important, passion for the industry to this new position.

The entertainment industry is fiercely competitive, but for those interested in pursuing this path Jakgeem advises, "It is imperative to take advantage of as many networking opportunities and internships as you can. Know your audience and be respectful of their time; more important, be professional. There are hundreds of people competing for one position. You will get a lot of no's but it only takes one yes to jump start your career."

Jakgeem will join other TJSU alums practicing in the entertainment and sports law in a panel discussion to offer their experiences and advice on Saturday, April 12, at 1 p.m. in Room 325.

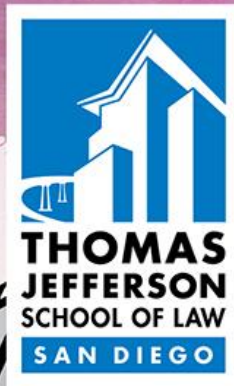

Academic Success & the Writing Center Spring 2014 Workshops

Mixed Multiple Choice Madness (Designed for Second Semester 1Ls)

Friday, March 28, 11:30am – 12:45pm, room 227

This workshop is designed with second-semester 1Ls participating in the bar-like final exam experience in mind. It will review some strategies and tactics for preparing for mixed-multiple choice exams, and provide some techniques for taking the mixed multiple choice exams. Participants will have an opportunity to practice some mixed-multiple choice questions.

Overcoming Analysis Paralysis

Wednesday, April 2, 11:30am – 12:45pm, room 229

This workshop aims to help students develop their legal reasoning skills through written analysis. It will provide students with practical structures for use on essay exams and give students an opportunity to practice identifying and explaining legal reasoning. Students will participate in an Analysis Bee and construct analysis by applying law to fact in a structured way.

Multiple Choice Workshop, sponsored by La Raza

Saturday, April 5, 10:00am – 12:00pm, room 323

This workshop will focus on effective strategies and tactics for multiple choice questions. Learn about the anatomy of multiple choice questions and how to weed out distractor answers from the best answer. Students will practice the strategies learned during the workshop to assist in honing their multiple-choice test-taking skills.

Grammar Bootcamp: Capitals, Periods and Everything In Between

Tuesday, April 8, 11:30am – 12:45pm, room 229

Learn how to avoid making writing mistakes in your timed and polished writing assignments. This workshop focuses on 18 rules that help ensure clear, coherent writing under high-pressure writing conditions.

1L Bar Orientation (Mandatory for students graduating in the 2014-2015 academic year)

Thursday, April 10, 11:30am – 12:45pm, room 323

To become a licensed attorney, law graduates must take and pass a bar exam. Learn about the California and Uniform Bar Exam options available, what's on the Bar and how the Bar is graded, and what you can (and should) do to prepare for the exam. This orientation will also cover bar-related course requirements and options for students during their final year, as they prepare for the bar exam.

Preparing for Mixed Subject Final Exams (Designed for Second-Semester 1Ls)

Thursday, April 17, 11:30am – 12:45pm, room 229

This workshop is designed to help students preparing for the 1L Bar-Like Experience get ready for final exams. It will discuss how to use subject-specific materials to plan and prepare for finals. This workshop includes a brief overview of time management and planning strategies for the last month of classes, leading up to finals. Students participate in a reverse-scheduling and calendaring exercise to plot out what they need to do to successfully prepare for exams, so each participant leaves with a final exam study schedule.

Winning the Finals Fight – Outlining, Scheduling and other Essential Studying

Friday, April 25, 11:30 – 12:45 pm, room 225

This workshop includes a brief overview of time management and planning strategies for the last month of classes, leading up to finals. Students participate in a reverse-scheduling and calendaring exercise to plot out what they need to do to successfully prepare for exams, so each participant leaves with a final exam study schedule.

Testing Labs:

Testing Labs provide an exam-like setting, complete with exam proctors and exam protocols. This gives students the opportunity to familiarize themselves with exam topics and timed-writing, including by assessing time-management skills. Participants should bring an exam question (or questions) and any materials they need to complete the exam, including their laptop (with the ExamSoft Mock Template or Word). ASP will provide space, a proctor, and Bluebooks for hand-writers. The rooms fill on a space-available basis.
