TJSL Aids In Philippines Relief Efforts

In the aftermath of Super Typhoon Haiyan hitting the central Philippines on November 8, TJSL Alums and student organizations came together to collaborate relief efforts. They called on the TJSL community for help with money, non-perishable food items, and household supplies.

"It is heartbreaking to see the extent of the damage of the recent super typhoon that hit the Philippines. Thousands perished and more than half a million lost their homes. Food, water and medicine are badly needed. I feel that it is our responsibility to help in any way we can to alleviate the suffering of those who survived this

calamity," said TJSL student and Disaster Relief Organizer Ian Seruelo (2L) --who comes from the devastated area.

TJSL Alum Edward Pamintuan, Esq. '06 coordinated with LBC Express, a Filipino-American door-to-door carrier to ship donations for Philippine relief efforts for free. Donated items collected at TJSL or at any LBC Express location will be shipped to the Philippine Red Cross to be immediately distributed.

"I was impressed with how quickly the staff at Thomas Jefferson School of Law sprang into action after I let them know that LBC Express would be shipping donations for the Philippines relief effort for free," said Pamintuan. "Also, Ian did excellent work by starting the disaster relief fund."

Seruelo rallied several student organizations to launch the Disaster Relief Fund Drive.

Sponsoring student organizations include: TJSL Student Bar Association, Labor & Employment Law Association, Immigration Law Society, Asian-Pacific American Law Students Association, Public Interest Law Foundation, Black Law Students Association, La Raza Students Association, National Lawyers Guild, Outdoors Club, and the Environmental Law Society.

TJSL Unveils New Military Website

In recognition of the fact that Thomas Jefferson School of Law has long been a leader in educating active duty service members, veterans, reservists and military spouses, the school has unveiled a new website designed to streamline the information and application process for those with a military connection.

The website, www.tjsl.edu/military, brings together a collection of resources designed to be especially relevant for those navigating the

waters of a career transition after military service, or during a spouse's military service. The site provides prospective applicants with information about military-specific financial aid options, flexible curricular options, military-focused clinical offerings, and upcoming events that involve the campus military community. The website also provides profiles of current TJSL students and recent graduates who made the transition from military service to student life at TJSL.

The school launched the website following years developing a reputation for being a leader in educating students with a military background. This year, 11% of the fall entering class was made up of those who had served in uniform. The school also welcomes a large number of military spouses, a large proportion of whom are living in San Diego on an active duty service member's military orders. TJSL has a campus chapter of Student Veterans of America, which is a key component in the school's reputation for camaraderie among those who have served. The school also provides students with an opportunity to gain hands-on law practice experience through the Veterans Legal Assistance Clinic, which provides free legal representation to veterans who have a variety of legal needs. Student veterans are particularly drawn by the opportunity to gain law practice experience while helping fellow veterans.

Dean Thomas Guernsey marked the launch of the website as evidence of the school's commitment to meeting the needs of service members and their families. "The Navy and the Marine Corps have played unique roles in shaping the history and culture of San Diego, and the military community has played a major role in shaping the campus community here at TJSL," said Dean Guernsey. "Among our most important goals at TJSL is delivering an academic program that meets the needs of our service members and their families, with the financial support required to make a law education possible. That's why I am so proud that so many military students choose TJSL."

"I am excited about the launch of the new military website at TJSL," said Jennifer McCollough, a former Navy helicopter pilot who graduated from TJSL in 2013 and who now holds a prestigious federal clerkship in the Eastern District of Texas. "During my time at TJSL, the school was unfailingly flexible in helping me meet the demands of active duty service while continuing my commitment to excellence in my academic endeavors. I hope the site helps other soldiers, sailors, Marines and airmen find the same path to opportunity after military service."

The school owes its reputation as a leader in educating military-connected students in large part to its generous commitment to the Yellow Ribbon Program. The Yellow Ribbon program allows a large proportion of TJSL student veterans, and their spouses, to attend the school tuition-free. An even larger number of TJSL students attend law school using Post-9/11 GI Bill Benefits, and for many of those students, this entitlement pays for half of law school tuition outright. In addition to those military benefits, students who enter TJSL beginning in the January 2014 entering class will be eligible for a new slate of guaranteed merit scholarships, under a transparent and consistent system that allows applicants who are not using military benefits to clearly understand their prospective merit awards. The new military website provides applicants with a matrix laying out these award amounts.

"I am thrilled that the school has developed this new tool for reaching out to applicants from the military community," said Professor Bill Slomanson, a Navy veteran who works with many of TJSL's veteran applicants and students. "It was my own military service that brought me to San Diego, and I see in many of my military students the same desire to settle in this beautiful city. I'm proud that TJSL does such a wonderful job of training our military students for the next stage in their careers, especially because I observe, time and time again, that military students excel in the law school classroom."



Professor Byrnes Publishes 2nd Edition of International Withholding Tax Treaty Guide

LexisNexis Publishes 2nd Edition of International Withholding Tax Treaty Guide, Authored by Associate Dean William H. Byrnes and Dr. Robert J. Munro LexisNexis released in September 2013 the new and expanded 2nd Edition of its International Withholding Tax Treaty Guide. Thomas Jefferson's Associate Dean of Graduate & Distance Education William Byrnes is the co-author with Dr. Robert J. Munro, retired law librarian of University of Florida. This is William Byrnes and Robert Munro's sixth book together.

When asked about how Dr. Munro and he started working together, William Byrnes replied: "When I met him in 1998, Dr. Robert Munro was Co-Director of the Center for International Financial Crimes Studies at University of Florida's College of Law, focusing on anti money laundering and anti terrorism financing, whereas I focused on international taxation and multinational behavior. We explored several overlapping areas of interest, approaching each from our very different perspectives. Dr. Munro brings to the table his experience as a national security expert and his research into undocumented marketplaces whereas I bring my experience with multinational organization decision making and risk management."

"Dr. Munro has since retired from full time academia but still actively teaches anti money laundering for the Thomas Jefferson graduate program and provides its graduate and juris doctorate students with publication opportunities through the publication course to promote their professional careers. He has been particularly helpful with assisting students seek national security careers."

Regarding the 2nd edition International Withholding Tax Treaty Guide published this month, Robert Munro added: "The second edition of International Withholding Tax Treaty Guide includes a new binder with new chapter structures of completely rewritten tax information and analysis. The International Withholding Tax Treaty Guide has been expanded to include many new countries to match the robust list of 110 countries of Foreign Tax & Trade Briefs. Moreover, International Withholding Tax Treaty Guide subscribers will receive new chapters of analysis and planning based on the OECD Model DTA articles and major trading country jurisprudence that are most relevant to corporate tax counsel, addressing topics such as capital gains, dividends, interest, rents, leasing income, royalties, and permanent establishment. Corporate counsel may combine the Foreign Tax & Trade Brief publications with Tax Havens of the World to form an international tax planning and risk management library at substantially less cost than competitive product suites."

William Byrnes explained the history of this Lexis publication: "During the Second World War, Walter H. Diamond, then a banker, was tasked by the federal government to analyze and report on the investment and tax laws of each country and territory of which the Allies held confiscated Axis assets. Walter Diamond ventured though out the continents and Pacific meticulously collecting the local tax and investment laws and regulations applicable to the Allies new assets, and transcribed them into an understandable brief by country for the U.S. Treasury. In 1948, Matthew Bender published his country briefs in the first edition of Foreign Tax & Trade Briefs. Since 1948, the quarterly updated country briefs have been leveraged by thousands of multinational corporate counsel subscribers as part of their foreign tax and investments risk management best practices."

"In 1974, Matthew Bender added a third binder to Foreign Tax & Trade Briefs, International Withholding Tax Treaty Guide, to specifically address the important role of tax treaties in tax risk management that had developed in the sixties. By 1975, nearly 1,000 tax treaties had been signed between countries based on the OECD's Model with an additional 200 treaties in force based on the League of Nations Models. There are now more than 3,200 tax related treaties."

When asked about their next project together, Dr. Munro stated: "We are looking at tackling the rewrite of all three binders of Lexis' Tax Havens of the World, with a new table of contents, new chapters, and a more modern 'post-OECD reports' approach." William Byrnes added, "Yes, this major re-do should keep us creatively busy another couple years."

Professor Bisom-Rapp Goes to Paris

Thomas Jefferson School of Law Professor Susan Bisom-Rapp will be traveling again to Paris for the second Grey Zone Project colloquium from January 16-18. The Grey Zone Project, or ZOGRIS as it is known in France, is an international research project of more than 30 academics on the ZORGIS research team, which is funded by the French National Research Agency (Agence Nationale Recherche), a research funding organization established in 2005 by the French government.

Kicked off in 2011, the three-year comparative study aims to explore the rise of insecure forms of employment -- independent contracting, temporary employment, leased working, short-term contracts, self-employed freelancers and the like -- in a number of countries including, Brazil, the U.S., France, Germany, Italy, Mexico, and Peru.

"We are exploring the so-called "Gray Zone" of employment – employment that deviates from the traditional norm (e.g. temporary work, part-time work, independent contracting, leased work, etc.) -- and its ramifications," explained Professor Bisom-Rapp.

Of particular interest is the way these new employment relationships potentially increase inequality between groups of workers, and whether labor and employment laws must be amended to account for and cover those whose work deviates from full-time, long-term employment with a single employer.

The ultimate outcome of the research project will be the publication of at least one book compiling the work of the team.
