BLS & IPL Association Host Transactional Law Panel

The Business Law Society (BLS) and the Intellectual Property Law Association (IPLA) recently brought six transactional attorneys, including several TJSJL alumni, together to share what it is that they do on a daily basis in their law practices.

The panelists at the September 25th event included Eric Bernsen '12, Joshua C. Pearson, Lacy J Lodes '08, David B. Gibbs '12, Jeremy M. Evans '11 and TJSJL Adjunct Professor Danielle Barger, who teaches in the Solo Practice Concentration.

“This panel was very important because most students are not sure exactly what it means to be a transactional attorney,” said BLS President Jeremy Elias (3L). “All of the panelists were candid with their answers and were excited to their share experiences with everyone. The networking reception that followed allowed members to have more in depth conversations with our panelists, professors and other students. There was an incredible turnout for both the panel and the networking reception, and both organizations look forward to putting on future events.”

Lawyers perform a variety of roles in a transactional context, including the following: advising on the laws applicable to the transaction and on the appropriate structure that should be adopted to manage and minimize the legal and commercial; risks involved; drafting contracts and other documents; helping clients with the commercial negotiations; and helping clients with the management and execution (i.e. successful completion) of the transaction.

In addition to understanding the legal issues, transactional lawyers must develop the skills necessary to enable them to perform the above roles in an effective, efficient and ethical manner. They must also develop an awareness of the commercial context, including the client's commercial objectives, to ensure that the transaction works from both a legal and commercial perspective.

“So much of business today incorporates intellectual property,” said IPLA Vice President Stephanie Ferguson (3L). “There is a huge overlap between the two, and a majority of intellectual property law is transactional. William Byrnes & Jason Fiske Present on "Flipping the Classroom" at CaliBUG 2013

TJSL Associate Dean for Graduate and Distance Education Programs William Byrnes and Program Director Jason Fiske '08 stirred interest with their presentation on the topic of "flipping the classroom" at CaliBUG 2013, held October 11 in San Diego.

CaliBug had 280 attendees this year from California higher education institutions, representing administration and faculty of universities and colleges.

Last spring, Dean Byrnes submitted a presentation proposal to the conference committee on the pedagogical reasons for, and addressing the challenges of, "flipping the classroom," which was chosen for a forty minute slot at this year's conference.

According to Dean Byrnes, "Jason and I do a tag team presentation, swapping back and forth every couple minutes to keep audience interest. Listening to one speaker for forty minutes may be laborious, but fragmenting between two complementary styles and perspectives allows attention to be continually refreshed. Thus, I spoke to the pedagogical justification of flipping the classroom while Jason showed how we are flipping the classroom with screen captured examples."

As Dean Byrnes notes, there is growing research that supports the value effects of online education.

"I think it is important to start such distance education discussions by presenting the findings of the U.S. Department of Education Evaluation of Evidence-Based Practices in Online Learning - A Meta-Analysis and Review of Online Learning Studies:

'the meta-analysis of 50 study effects, 43 of which were drawn from research with older learners, found that students in online conditions performed modestly better, on average, than those learning the same material through traditional face-to-face instruction.'

"Also during the presentation, I dropped in the quote from another article that:

'Diverse groups of problems solvers – groups of people with diverse tools – consistently outperform groups of the best & the brightest.'"

As Jason Fiske noted, "The presentation, and the massive interest in the system we are creating, shows how the online Graduate Programs at Thomas Jefferson School of Law continue to lead as thought innovators and leaders in the continually evolving field of online education."

Dean Byrnes added, "During our presentation, a local law faculty member of USD expressed that she had been looking for exactly what we are doing. Moreover, several other institutions' faculty approached us at lunch to set up follow up conversations. Being chosen to speak at CaliBUG has presented a very good opportunity for cross fertilization with public universities in Southern California, like the UCs and Community Colleges, that are now exploring how best to leverage distance education to accomplish their missions of public education, as well as the private universities in attendance like USC, Loyola, and our neighbor USD."

Don't Miss Next Week's "Blurred Lines" Forum on Trolling for Patents

The attorney representing singer Robin Thicke in the pending legal battle over Thicke's huge summer hit "Blurred Lines" will be one of the featured panelists at an **October 18th** forum at Thomas Jefferson School of Law.

Presented by TJSJL, in association with the Entertainment Law Society, the Center for Law and Intellectual Property and the Intellectual Property Law Association, the forum is titled

"From Patents to Porn: The #Blurred Lines Between Intellectual Property #Trolls and Legitimate Intellectual Property Enforcement." The event is free, but registration is required at entertainment@tjssl.edu.

In the patent world, a troll is an entity that obtains patents for inventions it never intends to market. Instead, it lurks in the shadows to zap purported infringers with patent infringement suits. In the copyright world, so-called "sample trolls" are entities that create nothing, but control the music copyrights of artists and exist to find infringing samples or uses to extort payment. At the heart of any "trolls" business model is the litigation of controlled IP rather than the invention of useful inventions or the creation of great music or art.

This forum, featuring four highly accomplished patent and copyright lawyers, will explore the phenomena of IP trolls, from the world of technological invention to the world of film and music. From technological inventions under patent law, to pornography and musical works under copyright law, this provocative forum is expected to generate light and heat on a cutting-edge issue bedeviling IP law today.

The panelists will include: Stephen D. Rothschild, Esq., a partner with King, Holmes, Paterno, & Berliner, the firm representing Thicke, Pharrell Williams and Clifford Harris, Jr., in the "Blurred Lines" action; Fred Hernandez, Esq., Of Mintz, Levin, Cohn, Ferris, Glovsky, and Popeo, P.C.; David Branfman, Esq., of the Branfman Law Group, P.C.; and Joseph Re, Esq., Litigation Partner with Knobbe Martens.

TJSJL Professor Brenda Simons, who has practiced IP law, will be the moderator. TJSJL Professor K.J. Greene, who has represented a number of prominent clients in the music industry, and TJSJL student Chanel DiBlasi have organized the event. The law firms of Mintz Levin and Knobbe Martens are co-sponsors.

The event, which will take place in Room 229, from 4 - 6 p.m., will offer 1.75 of MCLE credit. A reception with the speakers will follow.

A is for Analysis

This workshop discusses "practicing" application – using practice questions to learn, not just to study for exams. This workshop illustrates using multiple choice questions, short answer questions, in-class hypotheticals, and practice questions from supplemental sources such as Examples & Explanations. Students will participate in an Explanation Bee game and construct an explanation or application of one of the issues/elements using the facts from the hypo.

GRAMMAR BOOTCAMP #1: Punctuation: Demystifying the Comma and Semicolon

This workshop reviews the correct use of the comma and semi-colon. The comma is most frequently used form of punctuation, but yet also the misused form. The workshop will discuss the basic comma rules that readers expect, the necessary commas that affect meaning and clarity, and commas for sophisticated writing. Further, students will review rules for using a semicolon effectively.

This workshop focuses on correct writing skills, and specifically, subject-verb agreement, subject-noun agreement, verb tense, parallel structure and possessives. Students will complete practice problems to reinforce correct writing and agreement.

Moving On After Miserable Midterms

This workshop focuses on evaluating and correcting midterm mistakes, bolstering student confidence in exam skills after disappointment, and looking ahead to finals. The workshop uses research on deliberate adjustments – critically examining mistakes, understanding how mistakes were made, coaching on how to correct mistakes, and practice application of corrections. Students will participate in reviewing and critiquing a student midterm essay exam.
