



## RSVP NOW FOR "MUSIC COPYRIGHT TERMINATIONS" PANEL ON SATURDAY, OCTOBER 20

"The ticking time bomb has arrived" is the sub-title of the all-star panel event at TJSJL this Saturday, October 20, that will examine "Music Copyright Terminations." Everyone is invited to attend the panel session from 11 a.m. to 2 p.m. in

Room 325, followed by a reception on the 8<sup>th</sup> floor. RSVP by October 17 at <http://alumni.tjsl.edu/events>.

Presented by the TJSJL Entertainment Law Society, in association with the Center for Law & Intellectual Property, this panel discussion is about the 1978 Copyright Act which provides that artists can terminate and regain copyrights assigned to record labels and music publishers 35 years after the copyright is granted. The panelists will explore the impact of the copyright terminations on the record labels – is this the death knell for the labels? Or, is this a new era for artist's rights?

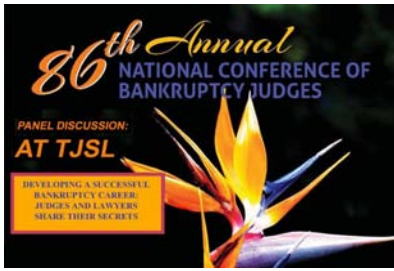
"There is, to paraphrase Marx, a specter haunting the music industry--the specter of copyright terminations from pre-1978 musical works," said TJSJL Entertainment Law Professor K.J. Greene.

"How this battle will turn out none can say, but at stake is a massive trove of music with astonishing financial worth. This forum brings perspectives from leading participants from both sides of the trenches, and promises to be fascinating and contentious. It is befitting a school like TJSJL, which sits on the cutting edge of intellectual property and is unique in its student-faculty-and practitioner's collaborations."

The first music copyright termination case involved composer Victor Willis, who wrote the hit song "YCMA" performed by the Village People. He successfully sued to terminate the copyright of the publisher. The Willis case is expected to lead to a tidal wave of music artists seeking to terminate copyrights currently held by the record companies and producers on 1970's era recordings and published music. Willis' attorney, Brian Caplan, will make a pre-recorded appearance at the event on Saturday.

Michael E. Tigar, who is considered to be one of America's greatest lawyers, will make two presentations at Thomas Jefferson School of Law on Tuesday, October 23, one of which is a cross-examination skills training session from 3 to 5 p.m. in the Moot Courtroom. Tigar, who is Emeritus Professor at Washington College of Law and at Duke Law School, will speak earlier in the day to the TJS� community about "Worker Rights Under Attack: Outsourcing and Globalization" in Room 323 from 11:30 a.m. -12:50 p.m.



"Michael Tigar is one of the most prominent criminal defense attorneys in the United States," said TJS� Professor Marjorie Cohn. "A brilliant speaker, Professor Tigar's work encompasses both incisive legal-political analysis and practice strategies for lawyers. This is a great opportunity to learn from a legal legend."

Professor Tigar has recently worked with labor and community organizations who are seeking a new set of legal protections for worker rights, nationally and globally. In this struggle many of the same themes can be seen that dominate discourse about transnational standards of accountability in other areas – environmental protection, financial fraud, and violation of human rights norms. As a new generation of lawyers prepares for practice, the "new" labor law provides them tools and opportunities.

In the past twenty years, the traditional legal analysis of worker rights has been altered. Labor law, as traditionally understood, is now transnational. Militant unions have worked to organize low wage and vulnerable workers in the United States. Powerful public and private forces, including major multinational corporations, have resisted these campaigns in four ways:

- outsourcing jobs within the United States,
- globalization – sending jobs to foreign countries where worker rights are fragile
- legislation to curtail or eliminate worker rights
- litigation attacks on union organizational campaigns

"Michael Tigar is an incredible speaker and an inspirational attorney," said TJS� Professor Meera Deo. "Faculty, students, alumni, and other local attorneys can all learn so much from his experience. We are fortunate to have him return to TJS�."

The TJS� Center for Law and Social Justice, the TJS� Faculty Colloquium Committee, the National Lawyers Guild-TJS� chapter, and the National Lawyers Guild-San Diego chapter are co-sponsoring these events, which are open to TJS� students, alumni, faculty and staff.

*Legendary Lawyer to Appear at TJSJ on October 23 continued...*

**About MICHAEL E. TIGAR:**

Michael E. Tigar is Emeritus Professor at Washington College of Law and at Duke Law School. He has taught at several law schools in North America, Europe and Africa. He is a 1966 graduate of Boalt Hall, University of California, Berkeley, where he was first in his class, Editor-in-Chief of the law review and Order of the Coif.

He has authored or co-authored thirteen books, three plays, and scores of articles and essays. He has argued seven cases in the United States Supreme Court, about 100 federal appeals, and has tried cases in all parts of the country in state and federal courts. His latest books are *Trial Stories* (2008) (edited with Angela Jordan Davis), *Thinking About Terrorism: The Threat to Civil Liberties in Times of National Emergency* (2007), and *Nine Principles of Litigation and Life* (2009).

His clients have included Isabel Letelier, the family of Ronni Moffitt, many victims of the Pinochet repression, Angela Davis, H. Rap Brown, John Connally, Kay Bailey Hutchison, the Washington Post, Fantasy Films, Terry Nichols, Allen Ginsberg, Leonard Peltier, the Charleston Five, Fernando Chavez, Karl Dietrich Wolff, and Lynne Stewart. He has represented labor organizations and rank and file workers. He has been Chair of the 60,000 member Section of Litigation of the American Bar Association, and Chair of the Board of Directors of the Texas Resource Center for Capital Litigation.

In his teaching, he has worked with law students in clinical programs where students are counsel or law clerks in significant human rights litigation. He has made several trips to South Africa, working with organizations of African lawyers engaged in the struggle to end apartheid, and after the release of Nelson Mandela from prison, to lecture on human rights issues and to advise the African National Congress on issues in drafting a new constitution. He has been actively involved in efforts to bring to justice members of the Chilean junta, including former President Pinochet. Justice William J. Brennan has written of Mr. Tigar's career that his "tireless striving for justice stretches his arms towards perfection."

Mr. Tigar is listed in Professor John Vile's book, *Great American Lawyers: An Encyclopedia* (2001), as one of 100 "great" lawyers in United States history. In 1999, the California Attorneys for Criminal Justice held a ballot for "Lawyer of the Century." Mr. Tigar was third in the balloting, behind Clarence Darrow and Thurgood Marshall. In 2003, the Texas Civil Rights Project named its new building in Austin, Texas, (purchased with a gift from attorney Wayne Reaud) the "Michael Tigar Human Rights Center."

Thomas Jefferson School of Law's Trademark Clinic has filed its first trademark application with the U.S. Patent and Trademark Office (USPTO) on behalf of a client, marking a major milestone for the recently established clinical program.

The USPTO announced in early August that TJSL is one of nine additional law schools in the nation selected for the Trademark Law School Clinic Certification Pilot Program, which allows TJSL students to practice trademark law before the USPTO under the guidance of a faculty supervisor.

The filing of the first application proved to be an exciting moment for everyone involved with the new TJSL Trademark Clinic, which is designed to provide assistance to small businesses, such as applicant Outreach Through Dance, and independent inventors who can't afford market rates for filing trademark and patent applications with the USPTO. Outreach Through Dance is a San Diego organization that produces dance events to benefit charitable organizations nationally and internationally.

"The program was able to help Outreach Through Dance with their trademark filings - something they probably couldn't have afforded without the resources of a student-driven clinic like the Trademark Clinic," according to Tim Dennison, the clinic's director.

"We needed both legal advice and services but, as a small charitable business, we couldn't fit them into the budget," says Melissa Adao, founder and

CEO of Outreach Through Dance. "We learned about the Thomas Jefferson School of Law Small Business Law Center and the Trademark Clinic, in particular, at the Little Italy Art Fair.

"This was a perfect solution for us," Adao adds. "We got great legal advice and had our trademark filed and we were able to keep to our budget. We are now going back to the SBLC for help with forming a non-profit. We would strongly recommend to other small businesses in the community to look into the services offered at these free clinics."

The TJSL Trademark and Patent Clinics were established earlier this year, after the school applied to the USPTO to be part of its law school pilot programs. In mid-July, the USPTO announced that Thomas Jefferson School of Law would be the only California law school to participate in its Patent Law School Clinic Certification Pilot Program. Two weeks later, TJSL learned that its Trademark Clinic also was selected.

The USPTO Selection Committee chose schools with the greatest potential for success, including those with strong Intellectual Property curriculums, like TJSL's, that support students' hands-on learning, a commitment to networking in the community, comprehensive pro bono services and excellent case management systems. Students working in the clinics received mandatory training from the USPTO.

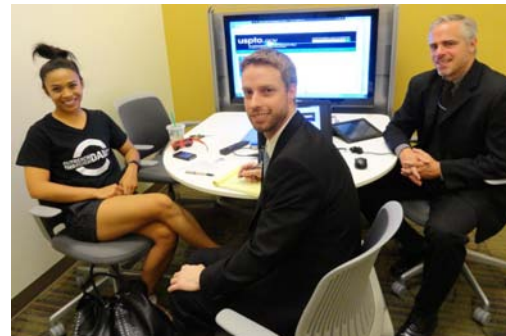
According to the USPTO, "the program allows law students enrolled in a participating law school's clinic program to practice Intellectual Property Law before the USPTO

under the strict guidance of a Law School Faculty Clinic Supervisor. The program currently consists of students practicing in both patent and trademark law before the USPTO. The program is administered by the Office of Enrollment and Discipline. The Director of the Office of Enrollment and Discipline grants the law students limited recognition to practice before the Office.

"Students gain experience drafting and filing either patent applications or trademark applications for clients of the law school clinic. Further, as they are authorized to practice before the USPTO, they gain experience answering Office Actions and communicating with either patent examiners or trademark examining attorneys for the applications they have filed."

A special feature of the pilot programs is that the USPTO will expedite the application review process for those filed by the law students. This will greatly benefit the clients of TJSL's Trademark and Patent Clinics as the normal application review process can take years.

The Trademark Clinic is just one of the free clinics TJSL operates to help people in need of legal assistance, from struggling veterans, to small business

people, to artists and art organizations, to individual taxpayers, to those involved in small claims and probate court cases that need the services of trained mediators.

"I feel very proud to be a part of the Trademark Clinic at Thomas Jefferson. I think all of the practical clinic programs: the Veteran's Clinic, the Small Business Law Center, VITA Tax Clinic, the Patent Clinic and the Trademark Clinic are fantastic resources, both for the students and the community," said Dennison. "This is a great program and Dean Hasl and the rest of the TJSL staff and faculty are to be congratulated for having the foresight, not only to focus on practical training for the students, but also for doing it such a way that the community benefits."

## Becoming a Black Belt... One Match at a Time

On September 9, 2012, I competed and placed first in the International Brazilian Jiu Jitsu Federation (IBJJF) American Nationals tournament as a Feather weight (116-130lbs). IBJJF is like the NFL or FIFA of Jiu Jitsu. The tournament took place in Long Beach and I was coached by my longtime friend and Thomas Jefferson Alum Lennie Alzate '10. She is a blue belt and my training partner. This event was very significant in my life because it was my first real win. I have been kickboxing for about four years and I always faced an uphill battle in the ring with more experienced opponents. A few weeks after this event, I also placed first in another Jiu Jitsu tournament called Grappling X.

First, I must describe the two different versions of BJJ in which I compete in: Gi and No gi. This refers to the Kimono, similar to what people see in Karate schools, only thicker because it's used for grappling. The No Gi events are much harder because opponents are slippery with the combination of sweat and spandex. When competing with the Gi, the match is a bit slower and you have thick cloth to grab and use against your opponent. I first started competing in No Gi and then I bought a Gi. I hated training with the Gi on because I train with mostly men and once they clutched on, I had no idea what to do. But I forced myself to go every day because I promised myself I wouldn't give up on something just

because it was hard. Even more importantly, at the time I started training in Jiu Jitsu I was suffering from a lot of personal problems. I was extremely depressed, but training in the morning and the evening gave me a sense of purpose and direction as well as the necessary endorphins to combat my depression.

I apply the skills I learn on the mat in school as well. When I am faced with a challenging subject, I remain calm and apply a consistent strategy to exams. And if I don't do so well, I let go and move forward.

A typical BJJ lesson begins with a warm-up, then a series of moves which we drill. After that, it's an open mat where we "roll" (our equivalent of sparring) and the goal is to apply the moves we just learned.

Between law school and Jiu Jitsu, the focus of my daily life is application. I have really grown to love BJJ and I am pursuing a Black Belt, which should take about 10 years if I compete with this level of consistency. As a feather and light feather competitor, I have yet to see a small Black Belt. Perhaps they exist somewhere; I just haven't come across any. I would like to be that woman and be an inspiration for other women and young girls to show them that you can be a good fighter against even the greatest opponent - which, more often than not, is yourself.

## Professor Luz Herrera Honored among "Women Who Mean Business"

TJSL Professor Luz Herrera has been named as a finalist in the *San Diego Business Journal's* 19th Women Who Mean Business Awards.

More than 150 women were nominated by the newspaper for this year's awards and all will be honored at a luncheon on November 6.

According to the *Business Journal's* announcement, the ceremony "will showcase dynamic female leaders who have contributed to the growth and vitality

of San Diego's business, civic and cultural landscape." In addition to the one-hundred-sixty-nine nominees, five women have been selected for special awards.

Professor Luz Herrera founded the Small Business Law Center at TJSL, and is also the co-founder and board president of Community Lawyers, Inc., a non-profit organization that provides low and moderate-income people access to affordable legal services and develops innovative opportunities for attorneys and law students in under-



served communities. She is pioneering a model to support public spirited, entrepreneurial lawyers in their efforts to launch successful law practices that assist clients and seek to strengthen communities.

## An announcement from Alex Kreit the Director of the Center for Law and Social Justice



The American Bar Association's Criminal Justice Section is continuing the "Citizen Amicus Project" in an effort to get law students to contribute to the national dialogue about the Fourth Amendment.

The 2012 Project focuses on the Fourth Amendment issues raised by law enforcement's warrantless use of trained narcotics dogs to detect narcotics from the outside of a home. This term the Supreme Court will hear *Florida v. Jardines*, a case that questions whether law enforcement's use of narcotic detection dogs in front of a home, without a warrant, violates the homeowner's Fourth Amendment right to be free from unreasonable searches.

The Supreme Court will review whether a dog sniff at the front door of a suspected grow house by a trained narcotics detection dog is a Fourth Amendment search requiring probable cause? Oral argument is October 31, 2012.

The American Bar Association's Criminal Justice Section believe law students have valuable insights to share about the question of an objective expectation of privacy.

*The top three filings will earn the American Bar Association's Criminal Justice Citizen Amicus Project recognition. The first place winner will receive \$500 and strong consideration of having his/her submission included in the Criminal Justice Section newsletter. The second and third place winners will receive a recognition plaque.*

*Submissions must be received before the Supreme Court issues its decision in the case.*

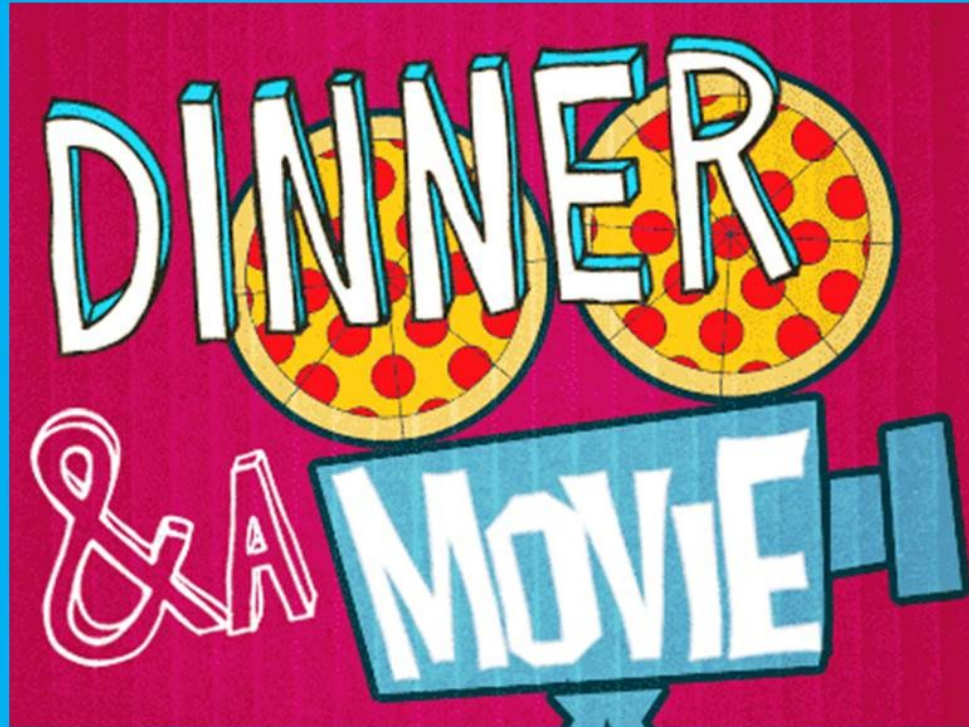

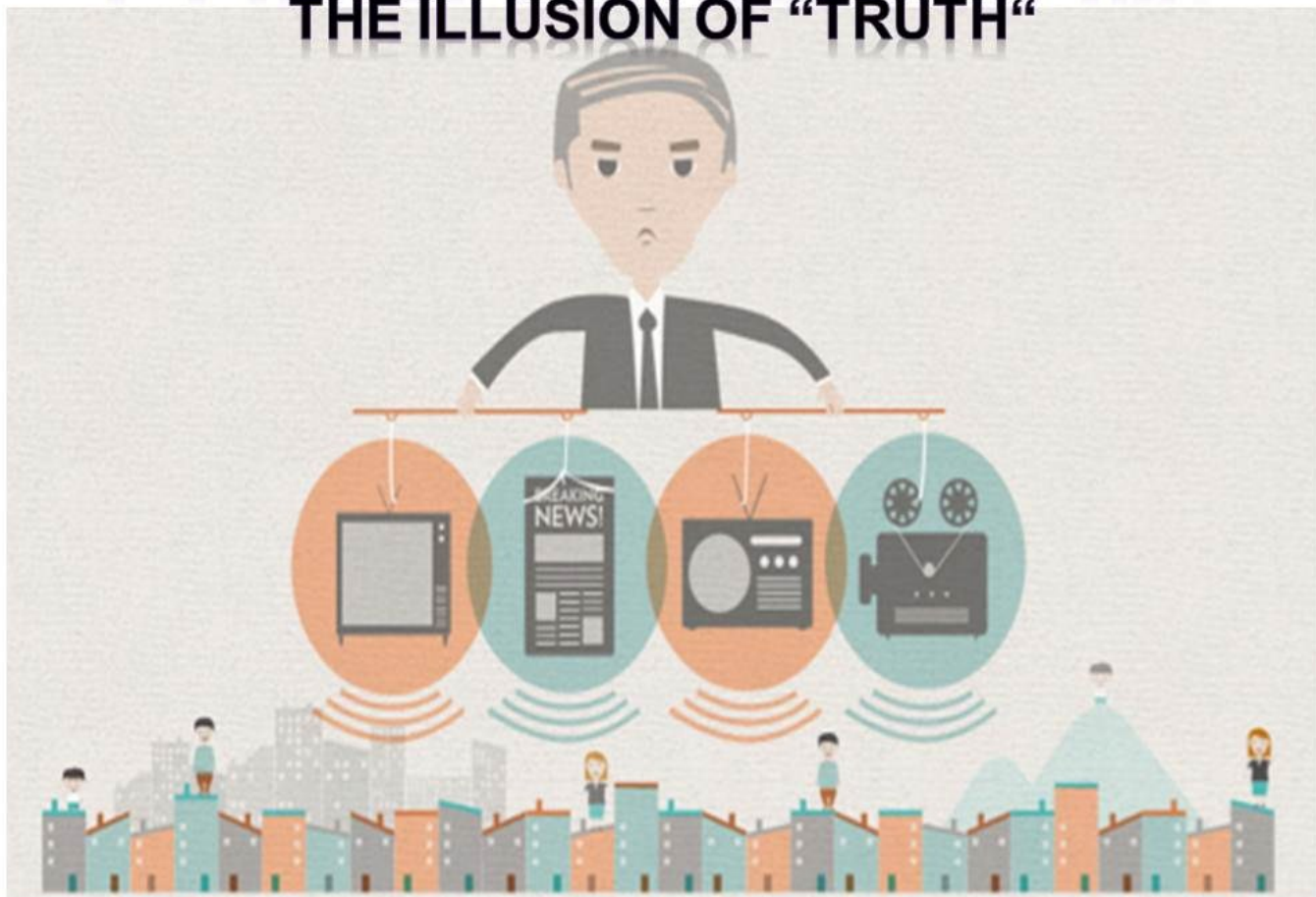

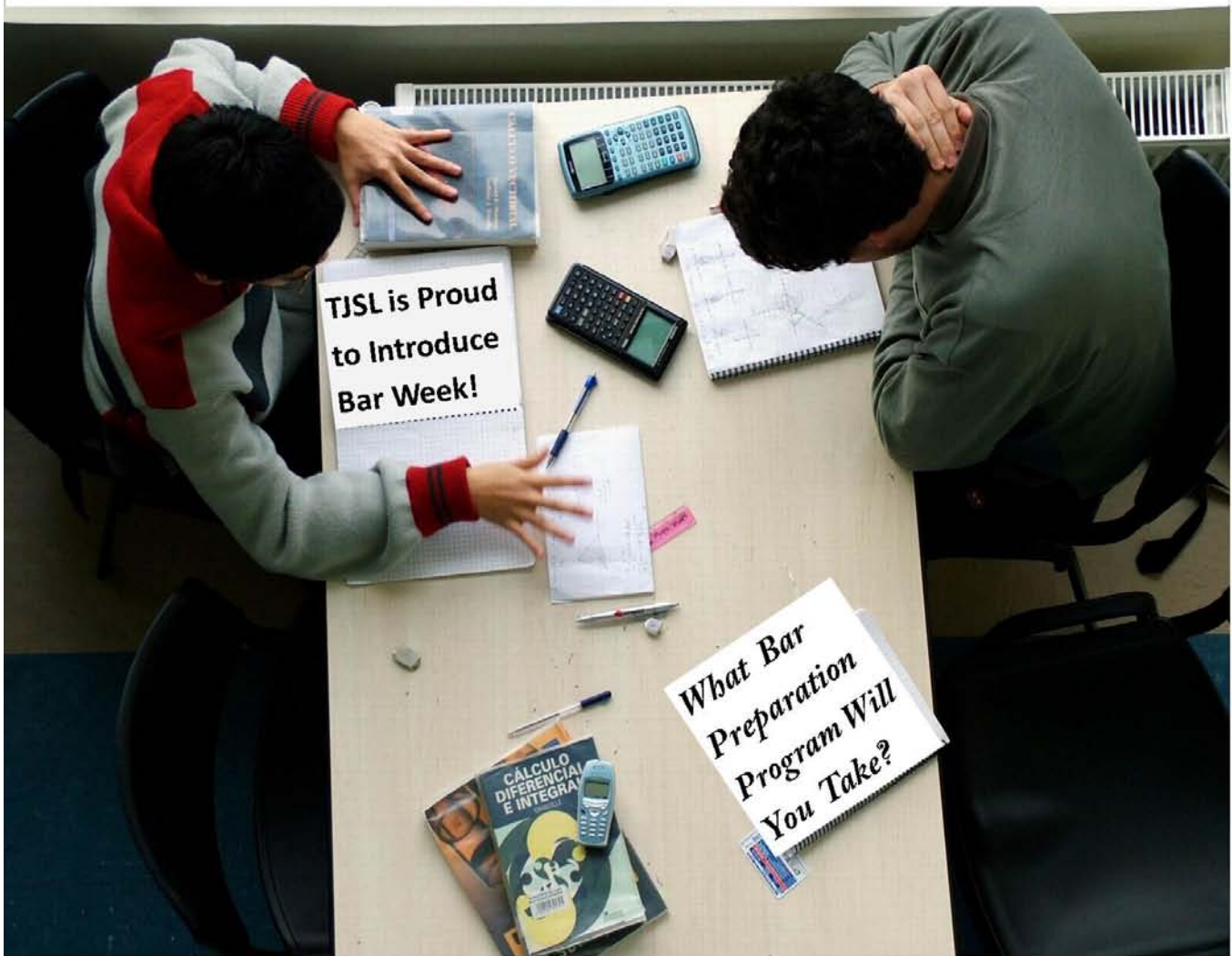
