

#### Gladiators in the 21st Century: Violence and Injuries in Sports Conference Coming to TJSL on November 10

They are the modern gladiators. They participate in society's most violent, bone-jarring spectator events. They are today's athletes.



They risk battered bodies and shattered limbs and, much worse, depression, dementia and possibly death as a result of traumatic brain injury, all the unnecessary consequence of the culture of violence that is pervasive in sports at all levels in today's world.

Sports at the pro, college, high school and even the grade school levels, especially football, have become blood sports. Athletes inflict intense and intentional bodily force

upon each other, quite often with the encouragement of coaches, peers and, worse yet, parents. A "win at all costs" mentality prevails in today's sports world at great cost: physically, mentally, emotionally and financially.

This gladiatorial culture of violence plays itself out on American football fields each fall. If we fail to deal with this inexcusable but preventable problem, the death knell may be sounding for football and other injury-prone sports as we now know them.

Thomas Jefferson School of Law's Center for Sports Law & Policy is tackling this critical problem by presenting "Gladiators in the 21st Century: Violence and Injuries in Athletics", a daylong conference at the law school on Saturday, November 10. This conference will examine the violence and devastating injuries that pervade sports and focus on finding solutions on the medical, legal, policy and cultural levels. What are the effects of this violence, both short-term and long-term? And, what can we do to change this culture of violence and protect today's athletes?

The event will feature highly engaging panels of distinguished legal and medical professionals as well as pro athletes. It is through well intentioned and well informed discourse, such as this conference, that acceptable and practical solutions will emerge.

The keynote speaker is legendary sports agent **Leigh Steinberg**, who has played a highly active role in getting the National Football League to address the problem of concussions among players.

In introducing this cutting edge conference, Professor Rod Smith, who Directs the Center for Sports Law and Policy at Thomas Jefferson said, "I am thrilled to announce that we are bringing leaders in medicine, law and sport to the law school to discuss and find solutions to the crisis of violence and injuries in sport." Smith added, "I fear that, if those who love sport fail to address these excesses, other will do the work for us and we will not like the result. We must find solutions."

#### Legendary Lawyer Appeared at TJSL on October 23

It's not every day that TJSL students, faculty and staff get to hear from a genuine legend.

And Michael Tigar is just that. He is among America's greatest lawyers, behind only Thurgood Marshall and Clarence Darrow, according to California Attorneys for Criminal Justice "Lawyer of the Century" balloting. That is select company.

He gave two presentations at TJSL on Tuesday, October 23; the first on labor law titled "Worker Rights Under Attack: Outsourcing and Globalization". The second presentation was a training in the art of crossexamination. These events were co-sponsored by The TJSL Center for Law and Social Justice, the TJSL Faculty Colloquium Committee, the National Lawyers Guild-TJSL chapter, and the National Lawyers Guild-San Diego chapter.

"Professor Tigar gave an entertaining and informative lecture at TISL, said Professor Meera Deo of the labor law presentation. "He spoke broadly on ways in which the rights of workers around the world are intertwined.

"I was inspired by the many ways he tied together concepts from various areas of the law and society generally. For instance, he made clear early on that if our immigration policy shifts to focus on deporting workers from factories in the United States, 'the sewing machines will follow' soon after as globalization encourages pursuit of the low(est)wage worker (whether domestically or abroad). It was also wonderful

to hear him draw on his wealth of experience as a litigator over decades of legal practice."

Quoting Bob Dylan, Professor Tigar said, "these times they are a changing," speaking of the challenges he feels those practicing labor law are going to face.

He geared his comments to two main themes: Outsourcing and Globalization, and how they are bound together.

Professor Tigar talked quite a bit about the history of labor law and the need for lawyers to continue to help workers through community meetings, which are protected under the First Amendment, despite efforts of many companies to use federal extortion statues under RICO to try to put a stop to the union organizing.

"The law of community organizing empowers communities to organize against outsourcing companies," he said.



Most of all, Professor Tigar stressed the personal commitment lawyers must make to the workers' cause. "American law is not doing the job for disadvantaged workers," he said.

"Professor Tigar stressed the importance of students using their legal skills to help the community," said Professor Marjorie Cohn, a close colleague of Tigar. "He discussed the benefits of setting up small law offices to defend workers who are organizing to protect their legal right to freedom of association."

"As lawyers, we have this opportunity to embrace the change that is coming," Professor Tigar said. "This challenge is the finest hour of lawyers to shape what the law needs to be to serve the people (workers) and contribute to their liberation."

Alonso Zavalasoto 2L attended the cross examination skills training later in the afternoon. "I'm glad our school is inviting prominent attorneys like Mr. Tigar. That's definitely a great way to learn new trial advocacy techniques," said Zavalasoto, who is interning at the Alternate Public Defenders Office. "I went to see Michael Tigar's seminar because he is one of the best criminal defense attorneys in the country and that's what I want to be: a criminal defense attorney at the Public Defender's Office. Several PDs attended the session and were talking about it at work."

Zavalasoto walked away learning some valuable tricks of the trade that he plans to put into practice. "His advice on the use of his hand in order to tell the jury that there are always two sides to every story during opening statement was brilliant and I will probably use it in my next Mock Trial competition. Also, his advice on how to discredit an expert witness during cross-examination was very informative as well."

"I was fascinated by Mike Tigar's presentation," said Andrew Eckhart 1L about Tigar's presentation. "Professor Tigar clearly has a strong belief in what former Supreme Court Justice Sandra Day O'Connor calls the 'Majesty of the Law'. He has learned to combine this belief with his respect for people and his skills as a litigator. This combination creates a tremendous enthusiasm for his profession which you can sense when you listen to him speak. He is the kind of person you definitely want to go out of your way to meet. All in all, it was a very enjoyable experience."

TJSL Professor Lilys McCoy also attended the cross examination skills training held in the Moot Court Room. "I think that the most useful piece of advice was that before you even begin crafting your cross examination, you have to make sure that you have to the best of your cross examination."

examination, you have to make sure that you have, to the best of your ability, collected every prior statement that the witness has made," she said.

McCoy explained why she attended the event. "One of the keys to being a good lawyer is finding and leveraging opportunities to learn and improve throughout your career," McCoy said. "There is always something new to be gained, especially from someone with the depth and breadth of experience of a Michael Tigar. Basically, anytime I have an opportunity to hear one of the lions of the profession speak, I jump at it. And, judging from the audience, so do many long-time local practitioners."

The cross examination skills training was open to local attorneys who received two hours of MCLE credit.

#### Music Copyright Termination Panel Rocks The House on October 20

Thomas Jefferson School of Law, the Entertainment Law Society, in association with the Center for Law and Intellectual Property presented an important and well-attended seminar on October 20, titled "Music Copyright Terminations: The Ticking Time Bomb Has Arrived."



The event drew a large audience

"The specter of music copyright terminations is hanging over the music industry," said TJSL Entertainment Law Professor K.J. Greene, who produced the conference. "At stake are many millions of dollars in copyrights in the signature songs of the Seventies. The question is will artists and performers win back their copyrights, as contemplated in the Copyright Act, or will labels and music publishers fight tooth and

nail to prevent terminations. The first wave of music copyright terminations begins in earnest in 2013, and precursor of what may come was glimpsed in Village People composer and singer Victor Willis. That is why we were delighted to kick off the event with a special video appearance by Brian Caplan, the attorney for Willis in the recent litigation over termination rights to songs such as 'YCMA' and 'Macho Man.'"

According to Professor Greene, "The panelists, including three TJSL grads who are achieving prominence in the IP/Entertainment field,

Lisa Cervantes '97, Valerie Dearth '03 and Lacy J Lodes '08, all performed superbly. Copyright termination is a complex, indeed byzantine issue, but the panelists really brought the nuances of terminations to life, and as panelist David Branfman, a top San Diego copyright lawyer said, it was a very quick three hours."

Najmah Brown 3L, who co-directed the event along with Camara Mathis 3L, stressed the importance of the conference for those who would practice music law. "For any practitioner in the Intellectual Property and Music realm of the legal practice, The Music Copyright Termination panel was definitely a must-attend event," Brown said. "The panel consisted of heavyweight attorneys and music executives, who shared a wealth of information regarding the matter. From the actual filing of a copyright termination to what provisions are necessary in the contracts. Key emphasis was on artists selecting their hit songs and

then re-negotiating those deals. It is not in the best interest of the artist to try to acquire publishing for their entire catalog of tracks. The cost of filing a copyright termination case can be very costly and would not be a benefit to the artist for renegotiating publishing for songs that will not generate revenue. The moral of the story is if artists or their heirs have a hit song from the 70's that is still generating revenue or can potentially be exploited for a profit then they should seek copyright termination. "

#### TJSL's Brazilian Program Director's Experience at the Brazilian Supreme Federal Court

Thomas Jefferson School of Law Brazilian Program Director Carla McEwen was recently selected from among hundreds of thousands of Brazilian attorneys to be one of seven lawyers who gave their sentencing opinions to Brazil's Supreme Federal Court in the biggest national corruption case in that country's history – the Mensalão case.

Here is her personal account of the events, which unfolded in court on October 24:

"On October 24th, I had the most extraordinary experience in my life at the Brazilian Federal Supreme Court. The justices fought among themselves. It was a big scandal.

I observed with admiration the utterance of the votes of the Minister Dias Toffoli. His legalistic, formal and observance of constitutional principles, the adversarial due process to guide the decisions, proved to be compatible with the US Legal System thus his candor with the others Supreme Court judges was impeccable.

Indeed, there is a rigorous analysis of the criminal evidence. The whole evidence must be applied uncontested and beyond reasonable doubt.

The legal system cannot condemn someone based upon assumptions and hearsay. There is a need for material evidence, irrefutable proof, the maximum force *in dubio pro* defendant.

What I could see is that some are condemned to serve the clamor of the media and the public, which has almost no legal knowledge.

So consider the position and candor of Minister Dias Toffoli unpolluted and consistent with American judges. My opinion is based on his decision."

McEwen was selected from among 50 lawyers whose names were submitted to the Supreme Court by the Brazilian bar associations to be considered for the honor of giving their sentencing opinions. She is not only the youngest attorney selected, but the only woman.

There were a total of 37 defendants in the Mensalão case, which involved a system of bribery where members of the ruling party were literally buying votes from members of other parties in the National Congress. The majority of those defendants were convicted.

TJSL's LEEP Program (Legal Education and Exchange Program), which McEwen directs, has brought dozens of Brazilian attorneys to San Diego to study the U.S. legal system.

#### Juan Melendez Talks to TJSL about His Death Row Experience on October 24

Seventeen years, eight months, and one day. On January 3<sup>rd</sup>, 2002, Juan Melendez was released from Union Correctional Institution in Florida, making Juan the 99<sup>th</sup> Death Row in mate to be exonerated and released from prison since 1973. Melendez had spent 17 years, 8 months, and 1 day on Death Row for a crime that he did not commit. In total, 141 individuals have been exonerated from Death Row.

To raise awareness of Proposition 34 on the California ballot, on October 24<sup>th</sup>, Thomas Jefferson's chapters of the National Lawyers Guild and Criminal Law Society hosted the event. The 8<sup>th</sup> floor terrace became a backdrop for Melendez's story of overcoming the suffering and tribulations he experienced while wrongfully on Death Row.

Melendez began with a description of his arrest for the murder of a man that he had never met and the subsequent trial. Crucial testimony was omitted from the trial and Melendez's alibi, though supported by the testimony of four other witnesses, was brusquely rejected.

Melendez could not read or write in English. "They never give me an interpreter. At that time, if I say five words in English, three of them would have been cuss words." Within seven days after the commencement of the trial, Juan was sentenced to death for a crime that he had not committed.

Once on Death Row, Melendez struggled to stay hopeful and maintain belief in the rightfulness of his innocence claim. The prison conditions were deplorable. The cells were infested with rats and cockroaches, and the food, slipped through slots on the cell doors on a tray, was barely edible.

Other inmates volunteered to teach Melendez how to read and write in English, and this gave him the ability to be actively involved in his appeals process. Through the first long decade on Death Row, he saw several of his friends commit suicide by hanging themselves with garbage bags. At his lowest, he also considered suicide, going so far as to obtain the necessary garbage bag. But his knowledge of his own innocence and his determination to prove it overrode his desire to end his suffering.

In 2001, Melendez had almost exhausted his appeals. His then- attorney came to him in tears, saying that another of her Death Row clients had been executed, and that she was no longer able to work on his case. She promised to refer his case to the best attorney she could find. Melendez's new attorney took control of the appeal case and investigation.

She interviewed the former public defender that had represented Melendez at his initial trial, and she was given permission to peruse old documents from the case. In a dusty storage bin, she found a video that contained a taped confession of the real killer, admitting his guilt in the murder.

It was quickly discovered that, at the time of the initial trial, both

prosecution and defense had been aware of the existence of this taped confession, but had failed to procure it and put it on the record. In light of this new evidence, Melendez was entitled to a new trial. The state of Florida declined to re-prosecute the case because the key witness, a jailhouse informant who was known to bear a grudge against Melendez, had died, and other witnesses had since recanted their testimony.

After 17 years, 8 months, and one day of incarceration, Melendez was released from prison. Upon release, he received \$100 compensation. He has not received any further compensation, nor has he received an official apology from the state of Florida.

Melendez's powerful presentation riveted the audience. Through his story, he was able to raise aware-

ness of Proposition 34, the abolishment of the death penalty ballot measure that Californians may vote on to ensure that what happened to him, where an innocent man faced death for a crime he did not commit, does not happen here.
