IP Fellows Start Patent Research Project

Thomas Jefferson School of Law Adjunct Professor Randy Berholtz and his team of Intellectual Property Fellows have begun a year-long IP Honors Research Project in furtherance of creating a rubric to aid bio-pharmaceutical companies and patent practitioners in deciding which countries to file for patent protection.

The goal of the honors research project is to provide life science companies and patent practitioners with a comprehensive guide regarding the countries where biopharma patents are filed, the countries where life science companies and patent practitioners should

file for patent protection, and the factors that life science companies and patent practitioners should take into consideration when strategizing for international patent protection.

The project will consist of the following: (1) a paper addressing: the background of patents, the questions of where do and where should bio-pharmaceutical companies file patents, the development of a decision tree addressing each country's rule of law and patentability, and a recommendation of further study in the area; (2) a survey querying practitioners as to their present filing habits and the rationale behind them; (3) a seminar titled "Where to File: A Rubric for Biopharma Practitioners" to be held Friday, April 11, 2014 at Thomas Jefferson School of Law; and (4) a published Law Review article summarizing all stages of the research project and its corresponding analysis.

Professor Berholtz is the Acting General Counsel and Secretary of Innovus Pharmaceuticals, Inc. He formerly served as Vice President, General Counsel and Secretary of ACON Laboratories, Inc.; Chief Operating Officer and General Counsel of IngleWood Ventures, a life sciences venture capital fund; and Acting General Counsel and Secretary, Nanogen, Inc., a public genomic products company.

This is the second IP Honors Research Project Professor Berholtz has led at TJSL. The first was in 2009 titled "Improving Patent Adjudication: An Updated and Revised Survey of Practitioners' Experience and Options".

This year's participating IP Fellows include: Vince Davies (2L), Katherine MacFarlane (3L), Derek Midkiff (3L), Sumant Pathak (3L) and Richard Schurman (2L).

Vince Davies holds a B.S. in Biochemistry (University of California, San Diego) and a M.S. in Molecular Biology (San Diego State University). Davies is patent bar eligible and presently works at Nanovega, Inc. as a Legal Intern.

Katherine MacFarlane received her B.S. in Biology, with a minor in Economics, from the University of Massachusetts, Amherst. MacFarlane is patent bar eligible with plans to sit for the exam in December 2013. She is also currently working at the University of California, San Diego in the department of Family Medicine.

Professors Bisom-Rapp and Lee Present Papers at the University of Nevada, Las Vegas

Professors Susan Bisom-Rapp and Rebecca Lee presented papers at the Eighth Annual Colloquium on Current Scholarship in Labor and Employment Law. This year's colloquium was held on September 27 – 28 and was hosted at the University of Nevada, Las Vegas (UNLV) by the William S. Boyd School of Law. UNLV Professors Ruben Garcia and Ann McGinley organized the conference. In 2008, Thomas Jefferson School of Law co-hosted the event in San Diego along with the University of San Diego and California Western Schools of Law.

"The annual colloquium has become the premier national conference for labor and employment law works-in-progress," said Professor Bisom-Rapp, "drawing labor and employment law professors from around the country." A highlight of this year's conference was a dinner hosted at the union hall of the Culinary Workers (Local 226). Accompanying the dinner was a panel, "Labor's History and Future in Nevada: From the Mines to the Casinos," featuring speakers who are labor leaders in Las Vegas and including a talk by labor historian Professor Michael Green of the College of Southern Nevada.

Professors Bisom-Rapp and Lee presented their papers at UNLV on September 27. Professor Bisom-Rapp's paper, "It's Complicated: Age, Gender, and Lifetime Discrimination against Working Women – the U.S. and the U.K. as Examples," is co-authored with Professor Malcolm Sargeant, who teaches at Middlesex University Business School in London, UK. The paper tackles a pressing problem facing women in old age – the problem of falling into poverty at the end of their lives. Women in both countries suffer from multiple disadvantages before and during their working lives, resulting in significantly poorer outcomes in old age when compared to men. Older women of color are especially disadvantaged. To address the causal factors, Bisom-Rapp and Sargeant develop a model of Lifetime Disadvantage, which considers the major factors that on average produce unequal outcomes for working women at the end of their careers. Integral to the model are the legal and policy efforts that lessen or magnify the factors' lifetime effects. Bisom-Rapp and Sargeant argue that regulatory schemes created on a piecemeal basis are unlikely to vanquish systemic inequality on the scale of gender-based lifetime discrimination. Indeed, recognizing the limitations of statutory and policy tinkering is the first step to developing a whole life approach to women workers that will bring greater economic equality in old age.

Professors Bisom-Rapp and Lee Present Papers at the University of Nevada, Las Vegas continued...



Professor Lee's paper, "Reconceptualizing the Judge a Public Leader," looks at how we understand the role of the judge, and the full range of work that judges engage in and should engage in. The most familiar part of the judge's work is adjudicating and this is understood as mostly solitary work. Although this is true to some extent, she shows that judges also work with others in important ways -- in their chambers, in their courtrooms, and in the courthouse, as well as outside the courthouse. Moreover, judges represent the third branch of government, an essential part of our system of democratic self-governance. In light of all that judges do as part of their work, and their clear place in our system of government, Professor Lee addresses two important questions: does the public view the judge as a leader in larger society?, and do judges view themselves as public leaders? As she points out, the concept or title of leader may not automatically attach to the judicial role because of a judge's duty to adjudicate impartially and fairly, without partisan loyalty and political motivations. But leadership involves more than just politically-oriented activities. As she argues, individuals who help the direct the work of others and demonstrate influence also may be seen as engaging in leadership activity. If we think about how one actually becomes a viable candidate for a judgeship, successful judicial candidates have demonstrated leadership to some degree. Once on the bench, these individuals do not stop their leadership work -- as judges, they instead engage in a different kind of leadership. Judges exercise authority in the most obvious way by deciding cases and writing court opinions. Judges also lead by serving as an employer to their court personnel and in how they operate their chambers and direct the work of their staff. Further, judges lead by representing the judicial branch to the public and to the other branches of government. To provide some qualitative data regarding judges' own perceptions about what they do as judges, Professor Lee's project will include an empirical component involving interviews with sitting federal and state judges. Professor Lee asserts in this work that judicial leadership is a significant but under-recognized aspect of a judge's work, and argues that we ought to reconceptualize the judge as public leader, in terms of how the public views judges as well as how judges themselves view their roles.

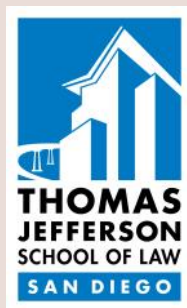
Countdown to Final Exams
